ORDER:

In the G.O first read above, among others orders were issued sanctioning a sum of Rs.75,00,00,000/-(Rupees Seventy Five Crores Only) for construction of the Tamil Nadu National Law School at Navalur Kuttapattu Village, Srirangam Taluk, Tiruchirapalli District.

2. The Engineer-in-Chief (Buildings) and Chief Engineer (Buildings), Chennai Region, Public Works Department, Chennai in the letter second read above has among others, sent proposal for revised administrative sanction for the work of construction of the Tamil Nadu National Law School at Navalur Kuttapattu Village, Srirangam Taluk, Tiruchirapalli District. In the said proposal, he has stated that based on the recommendation of the Technical Advisory Committee, the above said revised administrative proposal was placed in the 174th Tender Award Committee Meeting held on 19.10.2012 and the said committee, after detailed analysis, has accepted the revised administrative sanction proposal for a total amount of Rs.79,21,50,581/- (i.e. Rs. 4,21,50,587/- over and above the original administrative sanction amount of Rs. 75,00,00,000/-) for the above said work. As per the minutes of the meeting of the 174th Tender Award Committee, the details of excess expenditure are as follows:-

The Engineer-in-Chief (Buildings) and Chief Engineer (Buildings), Chennai Region, Public Works Department, Chennai has requested to accord revised administrative sanction for a sum of Rs.79,21,50,587/- i.e. Rs. 4,21,50,587/- over and above the original administrative sanction amount of Rs. 75,00,00,000/- for the work of construction Tamil Nadu National Law School at Navalur Kuttapattu Village, Srirangam Taluk, Tiruchirapalli District.

4. The Government, after careful examination have decided to accept the proposal of Engineer-in-Chief (Buildings) and Chief Engineer (Buildings), Chennai Region, Public Works Department, Chennai. Accordingly the Government accord revised administrative sanction for a sum of Rs.79,21,50,587/- (Rupees Seventy Nine Crores Twenty One Lakhs Fifty Thousand Five hundred and Eighty Seven Only) i.e. Rs. Rs. 4,21,50,587/- over and above the already sanctioned amount of Rs. 75,00,00,000/- for the work of construction of the Tamil Nadu National Law School at Navalur Kuttapattu Village, Srirangam Taluk, Tiruchirapalli District.

5. The additional expenditure due to the revised administrative sanction ordered in para-4 above shall be debited to the following head of account.

“ 4202 Capital Outlay on Education, Sports, Art and culture. 01. General Education – 203. University and Higher Education – Schemes in the Twelfth Five Year Plan.-II- State Plan – JA. Buildings – 16. Major works (DPC 4202-01-203-JA-1605).”

6. Necessary funds will be provided in Revised Estimate/Final Modified appropriation 2014-2015. However, this expenditure shall be brought to the notice of the Legislature by specific inclusion in the Supplementary Estimates 2014-15. Pending provision of such funds in Revised Estimate/Final Modified Appropriation 2014-2015, The Engineer-in-Chief (Buildings) and Chief Engineer (Buildings), Chennai Region, Public Works Department, Chennai is authorized to incur the expenditure sanctioned in para-4 above. The Engineer-in-Chief (Buildings) and Chief Engineer (Buildings), Chennai Region, Public Works Department, Chennai is requested to include the above expenditure while sending proposals for Revised Estimate/Final Modified appropriation 2014-2015, to Government in Finance (Home-II/BG-I/PW-I) Department along with necessary explanatory notes at the appropriate time, without fail.
