Order:

In the letter second read above, the Member Secretary, Sports Development Authority of Tamil Nadu has informed that the Government vide G.O. first read above has constituted a District Level Sports Advisory Committee (DLSAC) to monitor and to develop sports related activities in the districts. The Committee is headed by the District Collector with 16 official members. District Sports & Youth Welfare Officer is the Convener of the Committee. This has enabled wider consultation with various sectors and their involvement in sports development.

2. The Member Secretary, Sports Development Authority of Tamil Nadu has stated that at present, all the District Level Sports Advisory Committees are meeting regularly, once in two months except Chennai District. The District Collector, Chennai has not conducted the Committee meeting so far.

3. The Member Secretary, Sports Development Authority of Tamil Nadu has further stated that International standard infrastructure facilities are available in Chennai. To maintain the existing sports infrastructure facilities and to create more sports infrastructure facilities as well as to create awareness in sports and

games, it is necessary to conduct the District Level Sports Advisory Committee meeting regularly. He has further requested that the Commissioner, Corporation of Chennai may be nominated (instead of District collector) as the Chairman of the District Level Sports Advisory Committee, Chennai, as substantial sports infrastructure facilities in Chennai are under the control of Corporation of Chennai and the Corporation can also mobilize funds easily.

4. The Member Secretary, Sports Development Authority of Tamil Nadu has requested the Government, to issue necessary orders nominating the Commissioner, Corporation of Chennai as the President of District Level Sports Advisory Committee to conduct the meeting of the District Level Sports Advisory Committee, Chennai district, regularly.

5. The Government after careful consideration has accepted the request of the Member Secretary, Sports Development Authority of Tamil Nadu and accordingly order that Commissioner, Corporation of Chennai will head the District Level Sports Advisory Committee, Chennai instead of the District Collector, Chennai District as ordered in G.O. first read above.
