### **ORDER:**

In the G.O. read above, permission and administrative sanction have been accorded to the Managing Director, Tamil Nadu Tourism Development Corporation to conduct the 47<sup>th</sup> India Tourist and Industrial Fair 2023 at Island Grounds, Chennai and a sum of Rs.3,95,850/- (Rupees Three lakh and Ninety Five Thousand Eight Hundred and Fifty thousand only) has been allocated to Industries, Investment Promotion & Commerce and Micro, Small and Medium Enterprises Departments, among others, to participate in the Fair by erecting pavilion for the current year 2022-2023.

2. In this regard, it is considered that SIPCOT can be entrusted with the responsibility of putting up the Industries, Industries Promotion & Commerce Pavilion in consultation and coordination with other organizations under the control of this Department at the 47<sup>th</sup> India Tourist and Industrial Fair, 2023 to be held at Island Grounds, Chennai.

3. Accordingly, sanction is accorded for incurring an expenditure of Rs. 2,00,000/- (Rupees Two lakh only) towards participation of the Industries, Industries Promotion & Commerce Department in the 47<sup>th</sup> India Tourist and Industrial Fair, 2023 to be held at Island Grounds, Chennai.

4. The expenditure sanctioned in paragraph 3 above shall be debited to

“2852 Industries – 80 General – 001 Direction and Administration – State’s Expenditure – AA Headquarters Staff – 308 Advertising and Publicity – 02 Exhibition (DPC 2852 80 001 AA 30802)”

5. The Government direct that, the sum of Rs. 2,00,000/- (Rupees Two lakh only) shall be drawn under Article 99 of the Tamil Nadu Financial Code Volume-I by

the Industries Commissioner and Director of Industries & Commerce, Chennai and paid to State Industries Promotion Corporation of Tamil Nadu (SIPCOT).

6. The Government also direct that the Managing Director, SIPCOT shall be the Co-ordinator for putting up a Industries, Industries Promotion & Commerce Pavilion in the Fair. She shall also nominate a Nodal Officer to co-ordinate with the concerned organizations under the administrative control of the Industries, Industries Promotion & Commerce to decide on the nature of exhibits to be put up and exact requirement of space for the pavilion and to inform the Tourism, Culture and Religious Endowments Department, immediately, so as to enable that department to apportion the area to the Industries, Industries Promotion & Commerce Department.

7. A detailed report on the participation together with particulars regarding the actual expenditure incurred shall be submitted to the Government by the Managing Director, SIPCOT with a copy to the Tourism, Culture and Religious Endowments Department in due course.
