#### **ORDER:**

The Chairman and Managing Director, Tamil Nadu Urban Finance and Infrastructure Development Corporation Limited has therefore requested the Government to issue orders revalidating the orders issued in the Government Order first read above, so as to enable drawal of the said Rs.150.00 crore during the financial year 2015-16 for releasing the same to ULBs towards sanctioned payments under Integrated Urban Development Mission **(IUDM)**.

**3.** The Government after careful examination, accept the proposal of The Chairman and Managing Director, Tamil Nadu Urban Finance and Infrastructure Development Corporation Limited and accordingly validate the orders issued in the Government Order first read above, so as to enable the drawal of Rs.150.00 crore (Rupees One hundred and fifty crore only) sanctioned therein, during the financial year 2015-16 for release of the same to the IUDM projects approved by the Project Sanctioning and Monitoring Committee, as per the minutes of the Committee.

**4.** The Director of Municipal Administration is authorized to draw the amount sanctioned in para-3 and credit to the P.D. Account, viz. "Integrated Urban Development Mission Fund" maintained by the Tamil Nadu Urban Finance and Infrastructure Development Corporation Limited.
