#### ORDER:

During the Departmental review meeting held on 18.03.2013, the Hon'ble Chief Minister has approved Rs.5.00 crores as one time special grant for revamping the existing sports infrastructure facilities. Subsequently, in this regard the Hon'ble Chief Minister has also made an announcement on 14.05.2013 on the floor of the Tamil Nadu Legislative Assembly under Rule 110.

2. In this connection, in the reference read above, the Member Secretary, Sports Development Authority of Tamil Nadu has stated that the Government have created lot of infrastructure facilities in Tamil Nadu. For the Development of Sports in the District, the Sports Development Authority of Tamil Nadu is having District sports complex in all the districts except Tiruppur and Vellore. In addition, 24 swimming pools, 20 mini stadiums, and 4 multipurpose Indoor Stadia are also functioning under the control of Sports Development Authority of Tamil Nadu. Most of the District Sports Complexes constructed in the District units are more than 15 to 20 years old, which need to be renovated to be fit for playing. Detailed estimates are being prepared by the Public Works Department.

3. The Member Secretary, Sports Development Authority of Tamil Nadu has further informed that the following districts will be considered for major renovation in the District Sports Complex. The stadia below are in a bad state including swimming pools, galleries, etc.

- > Salem
- Coimbatore
- Madurai
- > Tirunelveli

The above said District Stadia will be renovated and upgraded utilizing Rs.4.00 crores out of the approved amount of Rs.5.00 crores. Further, he has furnished a list of various stadia wherein urgent repair / maintenance work are to be carried out for a sum of Rs.1.0005 crores.

4. The Member Secretary, Sports Development Authority of Tamil Nadu has therefore requested the Government to approve and sanction a sum of Rs.5.00 crores (Rupees Five crores only) as one time special grant to renovate the Infrastructure facilities and Sports Complexes in Tamil Nadu.

5. The Government after careful examination, sanction a sum of Rs.5.00 crores (Rupees five crores only) as one time special grant to Sports Development Authority of Tamil Nadu for carrying out major renovation in the District Sports Complexes of Salem, Coimbatore, Madurai, and Tirunelveli at a cost of Rs.4 crores and for urgent repair and maintenance works to the tune of Rs.1 crore in other sports complexes in the State as shown in the Annexure.

6. The expenditure sanctioned in para 4 above shall be debited to the following head of Account:-

"2204 – 00 Sports and Youth Services 104 - Sports and Games – Schemes in the Twelfth Five Year Plan-II State Plan – JW Grants to Sports Development Authority of Tamil Nadu for Establishment of Sports Complex - 09. Grants-in-aid-03 Grants for specific schemes" (DPC 2204 00 104 JW 0936)" Receipts

7. The expenditure sanctioned above shall constitute an item of 'New Service' and approval of the Legislature will be obtained in the due course of time. Pending approval of the Legislature the expenditure shall initially be met by an advance from the Contingency Fund, orders regarding which will be issued by the Government in Finance (BG-I) Department based on the application from the Member Secretary, Sports Development Authority of Tamil Nadu in the prescribed format along with a copy of this order. He is also requested to send necessary draft explanatory notes for inclusion of the expenditure in the Supplementary Estimates for the year 2013-14 without fail.

8. The Member Secretary, Sports Development Authority of Tamil Nadu shall determine the immediate requirement of funds out of total expenditure sanctioned above and apply for the Contingency Fund Advance as detailed above.

9. After the sanction of the Contingency Fund Advance, the Member Secretary, Sports Development Authority of Tamil Nadu shall prepare the bill and present the same to the Pay and Accounts Officer, Secretariat, Chennai-9 through the Under Secretary to Government, Youth Welfare and Sports Development Department, Chennai. The above sanctioned amount shall not be paid in cash and shall be credited into PD Account of Sports Development Authority of Tamil Nadu. (PD Account No.6184513932) by means of cheque under the following Head of account. "K Deposits and Advances (B) Deposits not bearing interest-8443 00 Civil Deposits – 800 Other Deposits –CH Deposits of Sports Development Authority (DPC 8443 00 800 CH 000D)"
