### ORDER:

During the Review Meeting held on 18.03.2013 the Hon'ble Chief Minister has approved the proposal for enhancement of Dietary Allowance to Rs.200/- per day for trainees of Centre of Excellence and Sports Hostels of Excellence from Rs.150/- and Rs.90/- respectively. Subsequently in this regard the Hon'ble Chief Minister has made an announcement under Rule 110 on the Floor of Tamil Nadu Legislative Assembly.

2. In this connection, in the reference read above, the Member Secretary, Sports Development Authority of Tamil Nadu has stated that the Sports Development Authority of Tamil Nadu is running Sports Hostel of Excellence (Boys) and Centre of Excellence for (Boys & Girls) in Tamil Nadu as follows, in which 80 Boys in Sports Hostel of Excellence and 25 Boys & Girls each (total 50) in Centre of Excellence are benefited every year under the scheme.

The existing Sports Hostel of Excellence and Centre of Excellence are having facilities like accommodation and play grounds. The trainees are trained systematically by NIS qualified coaches and are nurtured well. The students are being educated (academic) in the reputed College and Schools.

- 3. The Member Secretary, Sports Development Authority of Tamil Nadu has further stated that the Hon'ble Chief Minister has made an announcement in the Assembly that the Dietary charges will be enhanced from Rs.75/- to Rs.250/- for all the Sports Hostels. Hence, the Dietary charges for the Special Hostels like Sports Hostel of Excellence and Centre of Excellence functioning in Chennai may also be enhanced to higher than the Sports Hostels or same rate like Sports Hostel i.e. Rs.250/- per day per student.
- 4. The Member Secretary, Sports Development Authority of Tamil Nadu has furnished the tentative budget requirement for Sports Hostel of Excellence and Centre of Excellence with the dietary allowance equivalent to dietary allowance of Sports Hostels as follows:-

5. As the existing menu has been modified to cater to the caloric requirement of Sports person, utilizing the services of Nutrition experts, the Member Secretary, Sports Development Authority of Tamil Nadu has requested the Government to sanction a sum of Rs.1.04 crores as recurring expenditure for the year 2013-14 towards the dietary charges of existing strength in the Sports Hostel of Excellence and Centre of Excellence which includes the additional amount of Rs.55.40 lakhs required due to enhancement of dietary charges.

- 6. The Government after careful examination enhance the dietary charges of trainees in the Centre of Excellence and Sports Hostel of Excellence from Rs.150/-and Rs.90/- per day respectively to Rs.250/- per day and sanction a recurring grant of Rs.1.04 crores (Rupees one crore and four lakh only) for the year 2013-14 towards the dietary charges for the trainees in the centre of Excellence and the Sports Hostel of Excellence which includes the additional amount Rs.55.40 lakhs required due to enhancement of dietary charges.
- 7. The expenditure sanctioned in para 6 above shall be debited to the following head of Account:-

"2204 Sports and Youth Services 104 - Sports and Games – I Non Plan – AQ Grants to Sports Development Authority of Tamil Nadu for the Establishment of Sports Schools Sports Hostels and Specialized Sports Academies - 09 Grants -in-aid-01 Grants for Current Expenditure" (DPC 2204 00 104 AQ 0919)"

- 8. The expenditure sanctioned above shall constitute an item of 'New Instrument of Service' and approval of the Legislature will be obtained in the due course of time. Pending approval of the Legislature the expenditure shall initially be met by an advance from the Contingency Fund, orders regarding which will be issued by the Government in Finance (BG-I) Department based on the application from the Member Secretary, Sports Development Authority of Tamil Nadu in the prescribed format along with a copy of this order. He is also requested to send necessary draft explanatory notes for inclusion of the expenditure in the Supplementary Estimates for the year 2013-14 without fail.
- 9. The Member Secretary, Sports Development Authority of Tamil Nadu shall determine the immediate requirement of funds out of total expenditure sanctioned above and apply for the Contingency Fund Advance as detailed above.
- 10. After the sanction of the Contingency Fund Advance, the Member Secretary, Sports Development Authority of Tamil Nadu shall prepare the bill and present the same to the Pay and Accounts Officer, Secretariat, Chennai-9 through the Under Secretary to Government, Youth Welfare and Sports Development Department, Chennai. The above sanctioned amount shall not be paid in cash and shall be credited into PD Account of Sports Development Authority of Tamil Nadu. (PD Account No.6184513932) by means of cheque under the following Head of account.
