### **Order:**

Hon'ble Chief Minister has made an announcement on 14.05.2013 on the floor of the Assembly under Rule 110 for establishment of National Cadet Corps Training Academy at Madurai.

2. The Deputy Director General, National Cadet Corps has stated that the National Cadet Corps Department of the State of Tamil Nadu caters to the training requirement of over one lakhs cadets. Presently the National Cadet Corps depends on the institutions for their training grounds for completion of the camping syllabus. With increasing urbanization and corresponding pressures on the institutions, they are unable to spare their premises as per the requirement of the National Cadet Corps other than during their planned academic breaks. Thus all camping activities are restricted to the short periods of the vacations. Even during vacation, Institutions conduct short Vocational Courses. Large number of camps needs to be held simultaneously across the State which imposes a severe pressure on training resources and instructional staff and as a result quality of training is adversely affected. Thus there is an inescapable need to establish a training facility for the National Cadet Corps in the State of Tamil Nadu.

3. Further he has stated that the District Collector, Madurai District has identified land comprised in Survey No.79/6, present Survey No.79/8 measuring an extent of 3.14.80 Hectare at Idayapatti village, Madurai North Taluk, Madurai District for allotment to National Cadet Corps for establishment of National Cadet

Corps Training Academy and has also accorded pre-entry permission. The Tahsildar, Madurai North Taluk has handed over the possession of the above identified land to the Commander, National Cadet Corps Group Headquarters, Madurai and the same is under the possession and occupation of National Cadet Corps Department.

4. The Deputy Director General, National Cadet Corps has requested the following training infrastructure at the proposed Training Academy:-

(a) ADMINISTRATIVE BLOCK FOR THE ACADEMY STAFF:

It is proposed to re-locate one or two units from Madurai to the Training Academy to form the core administrative support for the Academy. The site is located approximately 30 kms from Madurai and has no support facilities in close proximity to the proposed site and therefore there is need to develop all basic facilities and ancillary services.

(b) CADETS BLOCK

- i) 700 Cadets (Separate for Boys and Girls)
- ii) 20 Associate National Cadet Corps Officers (Male & Female)
- iii) 20 State Government Staff
- iv) Guest Rooms for Training Team (Officers, Junior Commissioned Officers & Permanent Instructional staff) and Visiting / Inspecting Officers

(c) TRAINING FACILITIES

- i) Firing Range (10 meters to 50 meters)
- ii) Obstacle Course
- iii) Drill Square
- iv) Physical Training / Play ground

(d) INSTRUCTIONAL BLOCK

- i) Class Rooms and Language / Computer Labs
- ii) Kote Magazine
- iii) Auditorium
- iv) Dining Hall and Cook House
- v) Store room for training and administrative stores

(e) VEHICLE GARAGE SHELTERS

(f) GENERATOR ROOM

5. The Deputy Director General, National Cadet Corps has also forwarded the Rough Cost Estimate of Rs.12.00 crores for construction of Training Academy at Idayapatti Village, Madurai District, as approved by Engineer-in-Chief (Buildings), Chepauk, Chennai and countersigned by the Deputy Director General, as follows:-

6. The Deputy Director General, National Cadet Corps has requested the Government to accord administrative and financial sanction of an amount of Rs.12.00 crores towards establishing National Cadet Corps Training academy at Madurai and for entrusting the work to the State Public Works Department.

7. The Government after careful examination and sanction a sum of Rs.12.00 crores (Rupees twelve crores only) as non-recurring expenditure for the Establishment of National Cadet Corps Training Academy at Idayapatti Village, Madurai North Taluk, Madurai District and to entrust the work to the State Public Works Department.

8. The expenditure sanctioned in para 7 above shall be debited to the following Head of Account:

4202 Capital outlay on EDUCATION, SPORTS, ART AND CULTURE. 03 Sports and Youth Services 800 Other Expenditure – II State Plan JC – Establishment of National Cadet Corps Training Academy 16 – Major works. [DPC 4202-03-800-JC 1603]

9. The Deputy Director General, National Cadet Corps is the Estimating, reconciling and controlling authority for the above said new head of account. The Pay and Accounts Officers / Treasury Officers concerned are requested to open the above said head of account in their books.

10. The expenditure sanctioned above shall constitute an item of 'New Service' and approval of the Legislature will be obtained in the due course of time. Pending approval of the Legislature the expenditure shall initially be met by an advance from the Contingency Fund, order regarding which will be issued by the Government in Finance (BG-I) Department based on the application from the Deputy Director General, National Cadet Corps in the prescribed format along with a copy of this order. He is also requested to send necessary draft explanatory notes for inclusion of the expenditure in the Supplementary Estimates for the year 2013-14 without fail.

11. The Deputy Director General, National Cadet Corps shall determine the immediate requirement of funds out of total expenditure sanctioned above and apply for the Contingency Fund Advance as detailed above.

12. After the sanction of the Contingency Fund Advance the Deputy Director General, National Cadet Corps shall prepare the bill and present the same to the Pay and Accounts Officer, Secretariat, Chennai. The Deputy Director General, National Cadet Corps is authorized to draw and disburse the amount. The Deputy Director General, National Cadet Corps shall send the Utilization Certificate to Government in due course.

13. This order issues with the concurrence of Finance Department vide its U.O.No.68429/Edn-I/2013, dated 27.11.2013 and Additional Sanction Ledger No.2159 [Two thousand one hundred and fifty nine].
