

## **ABSTRACT**

Mahatma Gandhi National Rural Employment Guarantee Scheme – Execution of Material Component works from the year 2013-14 and upto 2016-17 - Release of balance amount Rs.90.62 Crore as State Share for Material Component – Sanction accorded – Orders – Issued.

## **ORDER:**

The Director of Rural Development and Panchayat Raj in the letter read above has stated that Government of India have released funds to the tune of Rs.4552.7790 Crore to Tamil Nadu towards 1<sup>st</sup> tranche and 1<sup>st</sup> part of 2<sup>nd</sup> tranche of Central assistance for the year 2016-17. Further, Government of India while releasing the funds have informed that the State Government must transfer these funds along with the State Share to the State Employment Guarantee Fund for programme implementation within three days positively and it has been ordered that the Material Component is to be shared on 75:25 basis between the Central and State Government respectively. Accordingly, a sum of Rs.233.53 Crore (Rupees Two hundred and thirty-three crore and fifty-three lakh only) has been drawn as State Share so far vide Director of Rural Development and Panchayat Raj's Proceedings dated 16.08.2016 and 27.01.2017.

2. The Secretary Government of India, Ministry of Rural Development in the Letter No.J.12034/5/2017, MGNREGS VI dated 7.02.2017 have informed that there is a shortfall in the release of State Share under Mahatma Gandhi National Rural Employment Guarantee Scheme amounting to Rs.48.78 Crore during FY 2015-16 and Rs.306.03 Crore during FY 2016-17. In this connection, the Director of Rural Development and Panchayat Raj has stated that out of the total eligible State

Share of Rs.1009.15 Crore for the period from 2013-14 to 2016-17, a sum of Rs.918.53 Crore has been released as State Share and the balance to be released is Rs.90.62 Crore, the details of which are given below:

The Director of Rural Development and Panchayat Raj has also stated that the Government of India have been insisting for the release of State Share and during the Empowered Committee Meeting for sanction of Labour Budget for 2017-18 it has been informed that further funds would be released by Government of India only on release of the shortfall in State Share. Hence, sanction may be accorded for the drawal of a sum of Rs.90.62 Crore (Rupees Ninety crore and sixty-two lakh only) as balance State Share towards Material Component works taken up from the year 2013-14 and upto 2016-17.
- 4. The Director of Rural Development and Panchayat Raj has therefore requested to issue necessary orders for the drawal of State Share of Rs.90.62 Crore (Rupees Ninety crore sixty two lakh only) towards short fall in State Share to be drawn for the Material Component under Mahatma Gandhi National Rural Employment Guarantee Scheme works taken up from the year 2013-14 and upto 2016-17.
- 5. The Government after careful examination of the proposal of the Director of Rural Development and Panchayat Raj, accord sanction for a sum of Rs.90,62,00,000/-(Rupees Ninety crore sixty-two lakh only) towards shortfall in State Share for the Material Component under Mahatma Gandhi National Rural Employment Guarantee Scheme works taken up from the year 2013-14 and up to 2016-17.
