The following notification will be published in the Tamil Nadu Government Gazette:-

NOTIFICATION.

In exercise of the powers conferred by the proviso to Article 309 read with Article 313 of the Constitution of India and all other powers hereunto enabling, the Governor of Tamil Nadu hereby makes the following amendment to Rule 9-A of the Fundamental Rules.

2. The amendment hereby made shall be deemed to have come into force on the 1st January 2006.

AMENDMENT.

In the said Fundamental Rules, in Rule 9-A, for the expression starting with "Group –A" and ending with "Rs.2,610.", the following expression shall be substituted, namely:-

"GROUP 'A' – Government Servants in posts drawing Grade Pay of Rs.6,600/- and above;

GROUP 'B' – Government Servants in posts drawing Grade Pay of Rs.4,400/- and above, but below Rs.6,600/-;

GROUP 'C' – Government Servants in posts drawing Grade Pay of Rs.1,400/- and above, but below Rs.4,400/-;

GROUP 'D' – Government Servants in posts drawing Grade Pay of Rs.1,300/-."
