1. Letter No.14060/NI.1/2013, dated 07.10.2013 & 09.10.2013 from the Member Secretary, Sports Development Authority of Tamil Nadu.
2. Budget Publication No.66, (2014-2015) issued by the Finance (BG) Department, Chennai-9.

ORDER:

In the reference first read above, the Member Secretary, Sports Development Authority of Tamil Nadu has stated that the Government have accorded sanction for the construction of Multipurpose Indoor Stadium at Mogappair and sanctioned Rs.22.50 lakhs under part-II scheme for 2005-06. Subsequently Rs.45.00 lakhs have been sanctioned under Part II Scheme during 2006-07 and another Rs.31.85 lakhs under Revenue fund. Thus totally Rs.99.35 lakhs have been sanctioned for the Indoor Stadium. However the work could not commence due to various reasons. During 2014-15 the estimate for the multipurpose indoor stadium is Rs.133.00 lakhs. After the consultancy charges paid by Sports Development Authority of Tamil Nadu, a sum of Rs.93.50 lakhs is available with Sports Development Authority of Tamil Nadu.

2. The Member Secretary, Sports Development Authority of Tamil Nadu has therefore requested the Government to sanction an additional grant of Rs.39.50 lakhs as non recurring expenditure for construction of the above indoor stadium at a total cost of Rs.133.00 lakhs.

3. The Government after careful consideration, accept the request of the Member Secretary, Sports Development Authority of Tamil Nadu and accord sanction for a non-recurring grant of Rs.39.50 lakhs (Rupees thirty nine lakhs and fifty thousand only) additionally to the Sports Development Authority of Tamil Nadu for construction of multipurpose indoor stadium at Mogappair, Chennai under Part-II schemes (Component-I) for the year 2014-15.

4. The expenditure sanctioned in para 3 above shall be debited to the following head of account.

2204 00 Sports and Youth Services 104 - Sports and Games – Schemes in the Twelfth Five Year Plan II State Plan – JW Grants to Sports Development Authority of Tamil Nadu for Establishment of Sports Complex - 09 Grants-in-Aid-02. Grants for creation of capital assets. (DPC 2204 00 104 JW 0927)

5. The Member Secretary, Sports Development Authority of Tamil Nadu shall prepare the bill and present it to the Pay and Accounts Officer, Secretariat, Chennai-9 through the Under Secretary to Government, Youth Welfare and Sports Development Department. The amount sanctioned above shall not be paid in cash but shall be credited into following head of account by means of cheque.

6. The Member Secretary, Sports Development Authority of Tamil Nadu shall send the detailed expenditure report, utilization certificate etc., to Government at the appropriate time.
