#### **ORDER:**

In the reference first read above, the Member Secretary, Sports Development Authority of Tamil Nadu has stated that the Hon'ble Chief Minister has announced under Rule No.110 in the year 2011-12 that sports hostels will be established in 23 districts in a phased manner. Based on the announcement, in the first phase, sports hostels were sanctioned for 5 districts i.e. Coimbatore, Cuddalore, Thanjavur, Dindigul and Nagercoil at a cost of Rs. 60.00 lakhs each vide G.O.(Ms).No.17, Youth Welfare and Sports Development Department, dated 10.02.2012. During the year 2012-13, during second phase sports hostels were sanctioned in 6 districts i.e. Namakkal, Ariyalur, Tuticorin, Perambalur, Sivaganga and Theni with a provision of Rs.55 lakhs for the construction of sports hostel building and Rs. 10.00 lakhs for purchasing kitchen utensils and sports equipment as non recurring grant in G.O.(Ms).No.32, Youth Welfare and Sports Development Department dated 27.04.2013. The above 6 sports hostels have started functioning in the existing buildings. Due to escalation of cost, the amount sanctioned for construction building in the second phase is found to be inadequate. Further drain facilities, separate gas room, sick room etc. are needed to be provided in the above 6 sports hostel. The amount required would vary for each district. Overall an additional grant of Rs.110.00 lakhs would be required to fulfill all the required facilities in the sports hostels.

2. The Member Secretary, Sports Development Authority of Tamil Nadu has therefore requested the Government to sanction an additional grant of Rs.110.00 lakhs to fulfill all the required basic facilities in the 6 sports hostels.

3. The Government after careful consideration, accept the request of the Member Secretary, Sports Development Authority of Tamil Nadu and accord sanction for a non-recurring grant of Rs.110.00 lakhs (Rupees One crore and ten lakhs only) additionally to the Sports Development Authority of Tamil Nadu for fulfilling all the required basic facilities in the six sports hostel buildings being constructed in phase-II at Namakkal, Ariyalur, Tuticorin, Perambalur, Sivaganga and Theni, under Part-II schemes (Component-I) for the year 2014-15.

4. The expenditure sanctioned in para 3 above shall be debited to the following head of account.

2204 00 Sports and Youth Services 104 - Sports and Games – Schemes in the Twelfth Five Year Plan II State Plan – JW Grants to Sports Development Authority of Tamil Nadu for Establishment of Sports Complex - 09 Grants-in-Aid-02. Grants for creation of capital assets. (DPC 2204 00 104 JW 0927)

5. The Member Secretary, Sports Development Authority of Tamil Nadu shall prepare the bill and present it to the Pay and Accounts Officer, Secretariat, Chennai-9 through the Under Secretary to Government, Youth Welfare and Sports Development Department. The amount sanctioned above shall not be paid in cash but shall be credited into following head of account by means of cheque.

6. The Member Secretary, Sports Development Authority of Tamil Nadu shall send the detailed expenditure report, utilization certificate etc., to Government at the appropriate time.
