2. Budget Publication No.66, (2014-2015) issued by the Finance (BG) Department, Chennai-9.

ORDER:

In the reference first read above, the Member Secretary, Sports Development Authority of Tamil Nadu has stated that at present swimming pool facilities are available in 23 districts in the State and are under construction in 5 districts. A properly maintained pool is one that is visually and biologically clean. If the chlorine and PH levels are maintained, bacteria and algae will be destroyed and the pool will be biologically safe. Filtration is mechanical process of removing insoluble matter from the pool water. Further, water quality can be improved significantly and costs can be saved on the long term when ozone is applied for swimming pool water treatment. The filtration plant installed in swimming pools at Aquatic Complex, Velachery, Shenoyanagar, Madurai, Trichirapalli and Thanjavur are exhausted as they were installed around 10 years back. Hence it is proposed to replace it by installing a new filtration plant with ozone treatment at a cost of Rs. 15.00 lakhs each.

2. The Member Secretary, Sports Development Authority of Tamil Nadu has therefore requested the Government to sanction a sum of Rs.75.00 lakhs for the replacement of filtration plant with ozone treatment in the above swimming pools.

3. The Government after careful consideration, accept the request of the Member Secretary, Sports Development Authority of Tamil Nadu and accord sanction a non-recurring grant of Rs.75.00 lakhs (Rupees seventy five lakhs only) to the Sports Development Authority of Tamil Nadu for replacement of filtration plant with ozone treatment in swimming pools at Aquatic Complex, Velachery, Shenoyanagar, Madurai, Trichirapalli and Thanjavur under Part-II schemes (Component-I) for the year 2014-15.

4. The expenditure sanctioned in para 3 above shall be debited to the following head of account.

2204 00 Sports and Youth Services 104 - Sports and Games – Schemes in the Twelfth Five Year Plan II State Plan – JW Grants to Sports Development Authority of Tamil Nadu for Establishment of Sports Complex - 09 Grants-in-Aid-03. Grants for specific schemes (DPC 2204 00 104 JW 0936)

5. The Member Secretary, Sports Development Authority of Tamil Nadu shall prepare the bill and present it to the Pay and Accounts Officer, Secretariat, Chennai-9 through the Under Secretary to Government, Youth Welfare and Sports Development Department. The amount sanctioned above shall not be paid in cash but shall be credited into following head of account by means of cheque.

6. The Member Secretary, Sports Development Authority of Tamil Nadu shall send the detailed expenditure report, utilization certificate etc., to Government at the appropriate time.
