### ORDER:

In the reference first read above, the Member Secretary, Sports Development Authority of Tamil Nadu has stated that the Sports Development Authority of Tamil Nadu is implementing various Government schemes for development of sports and creating sports infrastructure in Tamil Nadu. As the Hon'ble Chief Minister is keen to develop water sports, it has been proposed to popularise and promote water sports in Tamil Nadu. Sailing has been fast emerging as a popular sport in Tamil Nadu. Besides, there are 10 events in sailing at the Olympics. Therefore, in order to enable the sailors of Tamil Nadu, practice regularly in preparation for National and International level competitions, competitive boats are essential. Initially 2 Racing Dinghy Boats at an estimated cost of Rs.40.00 lakhs at Rs.20.00 lakhs each have been proposed for purchase.



2. The Member Secretary, Sports Development Authority of Tamil Nadu has therefore requested the Government to sanction a sum of Rs.40.00 lakhs for purchasing two numbers of 49er Racing Dinghy boats.

3. The Government after careful consideration, accept the request of the Member Secretary, Sports Development Authority of Tamil Nadu and accord sanction of a non-recurring grant of Rs.40.00 lakhs (Rupees forty lakhs only) for purchasing two numbers of Racing Dinghy Boats under Part-II schemes (Component-I) for the year 2014-15.

4. The expenditure sanctioned in para 3 above shall be debited to the following head of account.

2204 00 Sports and Youth Services 104 - Sports and Games – Schemes in the Twelfth Five Year Plan II State Plan – JW Grants to Sports Development Authority of Tamil Nadu for Establishment of Sports Complex - 09 Grants-in-Aid-03. Grants for specific schemes (DPC 2204 00 104 JW 0936)

5. The Member Secretary, Sports Development Authority of Tamil Nadu shall prepare the bill and present it to the Pay and Accounts Officer, Secretariat, Chennai-9 through the Under Secretary to Government, Youth Welfare and Sports Development Department. The amount sanctioned above shall not be paid in cash but shall be credited into following head of account by means of cheque.

6. The Member Secretary, Sports Development Authority of Tamil Nadu shall send the detailed expenditure report, utilization certificate etc., to Government at the appropriate time.
