### **ORDER:**

In the reference first read above, the Member Secretary, Sports Development Authority of Tamil Nadu has stated that Tamil Nadu has a rich tradition of traditional sports which have been played by the locals for hundreds of years. However, gradually in the face of modern games like cricket, football, tennis etc, they are fast losing popularity and there may come a time when these games will be lost forever. It is of vital importance that these games are preserved and promoted at the local level. Games like Silampam, Oriyadi, Dayakattai, Aadupuli Aaddam, Kilyanthattu, Pallankuli, Killi, Nondi, Pambaram, Kannamoochi etc are some of the important traditional games still being played in various parts of the State. To make a good beginning, a festival of these traditional games may be organized in each district by the District Sports Council headed by the District Collector to preserve and promote these traditional sports. For each district Rs. 1.00 lakh may be given to host the games successfully.

2. The Member Secretary, Sports Development Authority of Tamil Nadu has therefore requested the Government to sanction a sum of Rs.32.00 lakhs for hosting the traditional games successfully in 32 districts at the rate of Rs.1.00 lakh for each district.

3. The Government after careful consideration, sanction a non-recurring grant of Rs.10.00 lakhs (Rupees ten lakhs only) to the Sports Development Authority of Tamil Nadu in four districts for hosting the traditional games as well as for its documentation under Part-II schemes for the year 2014-15.

4. The expenditure sanctioned in para 3 above shall be debited to the following head of account.

2204 00 Sports and Youth Services 104 - Sports and Games – Schemes in the Twelfth Five Year Plan II State Plan – JW Grants to Sports Development Authority of Tamil Nadu for Establishment of Sports Complex - 09 Grants-in-Aid-03. Grants for specific schemes (DPC 2204 00 104 JW 0936)

5. The Member Secretary, Sports Development Authority of Tamil Nadu shall prepare the bill and present it to the Pay and Accounts Officer, Secretariat, Chennai-9 through the Under Secretary to Government, Youth Welfare and Sports Development Department. The amount sanctioned above shall not be paid in cash but shall be credited into following head of account by means of cheque.

6. The Member Secretary, Sports Development Authority of Tamil Nadu shall send the detailed expenditure report, utilization certificate etc., to Government at the appropriate time.
