#### ORDER:

In the reference first read above, the Member Secretary, Sports Development Authority of Tamil Nadu has stated that the Hon'ble Chief Minister's Fitness for All programme is going to be implemented very shortly. Main objectives of the programme are to create health awareness amongst the people in Tamil Nadu as well as to improve the performance of the professional athletes. It is imperative to set up a State Sports Facilitation Centre in Chennai at Jawaharlal Nehru Stadium with medical and physiotherapy equipments such as BP apparatus, Virtual Model of joints, Defibrillator, Tera Band, Hydrotheraphy tub, BMI Machine, Fat analyzer, Wobble Board etc. to provide the best facilities to the athletes. This centre will definitely enhance the performance of International, National players by providing professional support in areas of Sports Medicine, Video Analysis, Bio-Mechanics and Physiotherapy etc.

2. The Member Secretary, Sports Development Authority of Tamil Nadu has therefore requested the Government to sanction a sum of Rs.314.86 lakhs for setting up of Sports Facilitation Centre in Chennai with all amenities.

3. The Government after careful consideration, accord sanction a non-recurring grant of Rs.50.00 lakhs (Rupees fifty lakhs only) to the Sports Development Authority of Tamil Nadu for setting up of State Sports Facilitation Centre in Chennai under Part-II schemes (Component-II) for the year 2014-15.

4. The expenditure sanctioned in para 3 above shall be debited to the following head of account.

2204 00 Sports and Youth Services 104 - Sports and Games – Schemes in the Twelfth Five Year Plan II State Plan – JW Grants to Sports Development Authority of Tamil Nadu for Establishment of Sports Complex - 09 Grants-in-Aid-03. Grants for specific schemes (DPC 2204 00 104 JW 0936)

5. The Member Secretary, Sports Development Authority of Tamil Nadu shall prepare the bill and present it to the Pay and Accounts Officer, Secretariat, Chennai-9 through the Under Secretary to Government, Youth Welfare and Sports Development Department. The amount sanctioned above shall not be paid in cash but shall be credited into following head of account by means of cheque.

6. The Member Secretary, Sports Development Authority of Tamil Nadu shall send the detailed expenditure report, utilization certificate etc., to Government at the appropriate time.
