### ORDER:-

In the letter first read above, the Vice-Chancellor(O), Tamil Nadu Physical Education and Sports University has stated that camping has become an essential part of one's life and education in the present world, particularly for city dwellers. Urban people are unable to get the sunshine, open air and open space most of the time. Organized camping aims to make up for this loss without the disadvantages of primitive life. A full-fledged Camping Centre will give the students exposure to nature. Besides other city inhabitants who are interested in using camping as a leisure activity could also utilize this facility. This will help to generate fund for the University.

2. The Vice-Chancellor (O), Tamil Nadu Physical Education and Sports University has requested the Government to sanction a sum of Rs.50 lakhs for establishing a Camping Centre in Tamil Nadu Physical Education and Sports University campus which has a beautiful sprawling campus with hillock in the background.

3. The Government after careful examination, have decided to accept the proposal of the Vice-Chancellor (O), Tamil Nadu Physical Education and Sports University and accord sanction for a sum of Rs.43 lakhs (Rupees Forty three Lakhs only) as non-recurring expenditure under Part-II schemes for the year

2014-2015 towards establishment of a Camping Centre in Tamil Nadu Physical Education and Sports University.

4. The expenditure sanctioned in para 3 above shall be debited to the following head of account:-

"2204 00 Sports and Youth Services – 101 Physical Education Schemes – I. Non Plan - AB Tamil Nadu Physical Education and Sports University - 09 Grants-in-aid – 02 Grants for creation of capital Assets" (DPC 2204 00 101 AB 0924)

5. The Vice-Chancellor (O), Tamil Nadu Physical Education and Sports University, Chennai-127 shall send the detailed expenditure report, utilization certificates etc., to the Government at the appropriate time.
