ORDER:-

In the letter first read above, the Vice-Chancellor (O), Tamil Nadu Physical Education and Sports University has stated that Tamil Nadu Physical Education and Sports University is a specialized university, first of its kind in India offering specialized courses of study in physical education and sports. Through Sports Technology Research Lab, the performance of athletes will be analysed through video analysis and multimedia guide will help in designing proper exercise regiments. To establish the facility, various laboratory devices and multimedia accessories have to be procured.

2. The Vice-Chancellor (O), Tamil Nadu Physical Education and Sports University has requested the Government to sanction a sum of Rs.48 lakhs for establishing a Sports Technology Research Laboratory as Centre for Video and Performance Analysis and multimedia guide for working out in gymnasium in Tamil Nadu Physical Education and Sports University.

3. The Government after careful examination, have decided to accept the proposal of the Vice-Chancellor (O), Tamil Nadu Physical Education and Sports University, Chennai-127 and accord sanction for a sum of Rs.48 lakhs (Rupees Forty eight Lakhs only) as non-recurring expenditure under Part-II schemes for

the year 2014–2015 towards establishment of Sports Technology Research Laboratory in Tamil Nadu Physical Education and Sports University.

4. The expenditure sanctioned in para 3 above shall be debited to the following head of account:-

“2204 00 Sports and Youth Services – 101 Physical Education – I. Non Plan - AB Tamil Nadu Physical Education and Sports University - 09 Grants-in-aid – 02 Grants for creation of capital Assets” (DPC 2204 00 101 AB 0924)

5. Necessary tender procedure shall be followed by Tamil Nadu Physical Education and Sports University for procurement.

6. The Vice–Chancellor (O), Tamil Nadu Physical Education and Sports University, Chennai-127 shall send the detailed expenditure report, utilization certificates etc., to the Government at the appropriate time.
