#### ORDER:

The Government Order first read above, the Government have sanctioned a non recurring grant of Rs. 3.50 crores for relaying of existing synthetic hockey surface at the Mayor Radhakrishnan Hockey Stadium, Egmore, Chennai.

2. The Member Secretary, Sports Development Authority of Tamil Nadu has therefore requested the Government to make arrangements immediately for releasing the fund as per Government Order for implementing the scheme during the financial year 2014-15.

3. After careful examination, the Government has decided to release a non recurring grant of Rs.3.50 crores (Rupees three crores and fifty lakhs only) sanctioned in the Government Order read above for relaying of existing synthetic surface at the Mayor Radhakrishnan Hockey Stadium, Egmore, Chennai.

4. Accordingly, the Government authorize the Member Secretary, Sports Development Authority of Tamil Nadu to draw the grant of Rs.3.50 crores, pending provision of additional funds in RE/FMA 2014-15.

5. The expenditure sanctioned above shall be debited into under the following head of account:-

“2204 – 00 Sports and Youth Services 104 - Sports and Games – Schemes in the twelfth Five Year Plan – II State Plan – JW Grants to Sports Development Authority of Tamil Nadu for establishment of sports complexes - 09. Grants-in-Aid-03 Grants for Specific schemes”  
(DPC 2204 00 104 JW 0936)”

6. Necessary funds will be provided in RE/FMA 2014-15. However, this shall be brought to the notice of the Legislature, by a specific inclusion in the Supplementary Estimates 2014-15. Pending provision of additional funds in RE/FMA 2014-15, the Member Secretary, Sports Development Authority of Tamil Nadu shall draw the grants as authorized in para 3 above and credit the same to the PD account of the Sports Development Authority of Tamil Nadu as per para 5 above. The Member Secretary, Sports Development Authority of Tamil Nadu is requested to include the expenditure in the proposal for RE/FMA 2014-15 without fail. He is also requested to send necessary supplementary note to the Government in Finance (BG-I/Edn-I) Department at the appropriate time.

7. The above sanctioned amount shall not be paid in cash but shall be credited into the following Head of account:-

"K Deposits and Advances (B) Deposits not bearing interest - 8443 00 Civil Deposits-800 Other Deposits-CH Deposits of Sports Development Authority (DPC 8443 00 800 CH 000D)" by means of Cheque / Demand Draft drawn in favour of PD Account No.6184513932.
