ORDER:

The Member Secretary, Sports Development Authority of Tamil Nadu has stated that the following Tamil Nadu players have won Medals and brought laurels to our Country in the XX Commonwealth Games – held at Glasgow from 23rd July to 3rd August, 2014:

- 2. As per the G.O. first read above, one of the conditions is that for sanction of Cash Incentives, the medal winners should be the resident of Tamil Nadu for the last 5 years, prior to winning the medals.
- 3. Out of the above said 7 medal winners, Thiru. Rupinder Pal Singh from Faridkot in Punjab has joined Indian Overseas Bank, Chennai during April 2010 and has been representing Tamil Nadu State Hockey Team in the various

National Tournaments. He is a resident of Tamil Nadu for 4 years and 3 months only. Though he has not fulfilled the condition stipulated in the Government Order based on his request, Government have relaxed the stipulated condition and announced the High Cash Incentive of Rs.30.00 lakhs to Thiru. Rupinder Pal Singh as a Special case. An appreciation letter has also been sent to Thiru. Rupinder Pal Singh on 07.08.2014, on behalf of the Hon'ble Chief Minister.

- 4. The Hon'ble Chief Minister presented the High Cash Incentive of Rs.30.00 lakhs to Thiru. Rupinder Pal Singh on 11.08.2014 at the Secretariat along with the other Medal winners. The above expenditure has been incurred from Sports Development Authority of Tamil Nadu funds.
- 5. Hence, the Member Secretary, Sports Development Authority of Tamil Nadu has requested the Government to sanction the Grant of Rs.30.00 lakhs to Sports Development Authority of Tamil Nadu, awarded as High Cash Incentive to Thiru. Rupinder Pal Singh, Silver Medal winner in Hockey in XX Commonwealth Games held at Glasgow from 23rd July to 3rd August, 2014 as a Special case.
- 6. The Government after careful consideration sanction a sum of Rs.30.00 lakhs (Rupees thirty lakhs only) as grant to Sports Development Authority of Tamil Nadu, towards the amount awarded as High Cash Incentive to Thiru. Rupinder Pal Singh, Silver Medal winner in Hockey in XX Commonwealth Games held at Glasgow from 23rd July to 3rd August, 2014 as a Special case in relaxation of the condition mentioned in para 7 (iii) of Government Order first read above.
- 7. The amount sanctioned in para 6 above shall be debited under the following Hed of account:

"2204.00. Sports and Youth Services-104. Sports and Games-I. Non-Plan-AR. Grants to Sports Development Authority of Tamil Nadu for Financial assistance to Sportsmen-09. Grants-in-aid-01. Grants for Current Expenditure" (DPC 2204 00 104 AR 0917).

- 8. Necessary funds will be provided in RE/FMA 2014-15. However, this expenditure shall be brought to the notice of the Legislature, by specific inclusion in the Supplementary Estimates 2014-15. Pending provision of additional funds, the Member Secretary, Sports Development Authority of Tamil Nadu is authorized to draw and disburse the amount. The Member Secretary, Sports Development Authority of Tamil Nadu is requested to include the same in the proposal for RE/FMA 2014-15. He shall also submit necessary Supplementary note to the Government in Finance (BG-I/Edn-I) Department at appropriate time without fail.
- 9. The Member Secretary, Sports Development Authority of Tamil Nadu is authorized to present the bill to the Pay and Accounts Officer, Secretariat,

Chennai-9, through Under Secretary to Government, Youth Welfare and Sports Development Department, Secretariat, Chennai-9. The above sanctioned amount shall not be paid in cash but shall be credited to the following head of account:-

"K.Deposits and Advances (B). Deposits not bearing interest -8443.00 Civil Deposits-800. Other Deposits-CH. Deposits of Tamil Nadu Sports Development Authority" (DPC No.8443.00.800.CH.000D) By means of Cheque / Demand Draft drawn in favour of PD Account No.6184513932.
