#### ORDER:

In the Government Order first read above, the Government have sanctioned and released the balance of the total grant amounting to Rs.2443.87 lakhs (Rupees twenty four crores forty three lakhs and eighty seven thousand only) to Sports Development Authority of Tamil Nadu as final instalment for implementing various schemes during the year 2013-14.

2. In B.E. 2014-15 a sum of Rs.7995.850 lakhs is provided to Sports Development Authority of Tamil Nadu under various heads of account for implementing the Sports Development Schemes by Sports Development Authority of Tamil Nadu.

3. In the letter second read above, the Member Secretary, Sports Development Authority of Tamil Nadu has furnished the Utilization Certificate for a sum of Rs.1703.41 lakhs (Rupees Seventeen crores three lakhs and forty one thousand only) out of final instalment of grant of Rs.2443.87 lakhs sanctioned in the Government Order first read above. He has also stated that a sum of Rs.740.46 lakhs (Rupees Seven crores forty lakhs and forty six thousand only) is available as balance in 2013-14. He has requested the Government to sanction and release first instalment grant of Rs.3257.465 lakhs i.e. 50% of the total grant provided in BE 2014-15 less the unspent balance available in 2013-14 for implementing various schemes during the year 2014-15 successfully. The Member Secretary, Sports Development Authority of Tamil Nadu has also furnished the headwise details to release the first instalment grant.

4. After careful examination, the Government sanction and release Rs.3257.465 lakhs (Rupees Thirty two crores fifty seven lakhs forty six thousand and five hundred only) (being 50% of total grant provided in BE 2014-15 less the unspent balance available in 2013-14) as first instalment to implement various schemes during the year 2014-15 as detailed in the annexure to this order.

5. The expenditure sanctioned in para 4 above shall be debited to the respective heads of account detailed in the Annexure to this order.

6. The Member Secretary, Sports Development Authority of Tamil Nadu shall prepare the bill and present it to the Pay and Accounts Officer, Secretariat, Chennai-9 through the Under Secretary to Government, Youth Welfare and Sports Development Department, Chennai. The above sanctioned amount shall not be paid in cash but shall be credited into the following head of account:-

"K Deposits and Advances (B) Deposits not bearing interest-8443 00 Civil Deposits – 800 Other Deposits –CH Deposits of Sports Development Authority (DPC 8443 00 800 CH 000D)" by means of Cheque / Demand Draft drawn in favour of PD Account No.6184513932.
