The Member Secretary, Sports Development Authority of Tamil Nadu has requested the Government to sanction Rs.240.00 lakhs (Rupees two hundred and forty lakhs only) towards the amount awarded as High Cash incentive to the above medal winners of the XX Commonwealth Games-held at Glasgow from 23rd July to 3rd August, 2014 to Sports Development Authority of Tamil Nadu.

4. The Government after careful consideration accord sanction for a sum of Rs.2,40,00,000/- (Rupees two crores and forty lakhs only) towards payment of High Cash incentive award to the above medal winners of the XX Commonwealth Games-held at Glasgow from 23rd July to 3rd August, 2014 to Sports Development Authority of Tamil Nadu.

5. The amount sanctioned in para 4 above shall be debited under the following head of account

6. Necessary funds will be provided in RE/FMA 2014-15. However, this expenditure shall be brought to the notice of the Legislature by a specific inclusion in the Supplementary Estimates 2014-15. Pending provision of additional funds RE/FMA 2014-15, the Member Secretary, Sports Development Authority of Tamil Nadu is authorized to present the bill to the Pay and Accounts Officer, Secretariat, Chennai-9 through Under Secretary to Government, Youth Welfare and Sports Development Department, Chennai-9. The Member Secretary, Sports Development Authority of Tamil Nadu is requested to include the same in the proposal for RE/FMA/SI 2014-15. He shall also submit necessary supplementary note to the Government in Finance Department at appropriate time.

7. The above sanctioned amount shall not be paid in cash but shall be credited to the following head of account:-
