ORDER:

In the reference first read above, the Member Secretary, Sports Development Authority of Tamil Nadu has stated that providing appropriate equipment for each sporting activity is an important step. Having good sports equipments lead to excellent overall performance. With technology advancements, the qualities of sports equipment have dramatically improved. Hence, it is proposed to procure athletics equipment such as starting block with microphone, gun, stop watch, electronic time board, lap scoring board, lane boxes, basket, hurdles, relay baton, range javelin, pole hurdles, electronic name board and scoreboard, etc. at a cost of Rs.67.00 lakhs for use at Chennai, Coimbatore, Madurai and Trichy (under construction) where synthetic athletics track facility is available.

2. The Member Secretary, Sports Development Authority of Tamil Nadu has therefore requested the Government to sanction a sum of Rs.67.00 lakhs as non recurring expenditure for procurement of above athletic equipments.

3. The Government after careful consideration, accept the request of the Member Secretary, Sports Development Authority of Tamil Nadu and accord sanction for a sum of Rs.67.00 lakhs (Rupees sixty seven lakhs only) as non-recurring grant to the Sports Development Authority of Tamil Nadu for procurement of athletic equipments as mentioned in para 1 above for the use at Chennai, Coimbatore, Madurai and Trichirapalli where synthetic athletics track facility is available, under Part-II schemes (Component-I) for the year 2014-15.

4. The expenditure sanctioned in para 3 above shall be debited to the following head of account.

2204 00 Sports and Youth Services 104 - Sports and Games – Schemes in the Twelfth Five Year Plan II State Plan – JW Grants to Sports Development Authority of Tamil Nadu for Establishment of Sports Complex - 09 Grants-in-Aid-03. Grants for specific schemes (DPC 2204 00 104 JW 0936)

5. The Member Secretary, Sports Development Authority of Tamil Nadu shall prepare the bill and present it to the Pay and Accounts Officer, Secretariat, Chennai-9 through the Under Secretary to Government, Youth Welfare and Sports Development Department. The amount sanctioned above shall not be paid in cash but shall be credited into following head of account by means of cheque.

6. The Member Secretary, Sports Development Authority of Tamil Nadu shall send the detailed expenditure report, utilization certificate etc., to Government at the appropriate time. Relevant tender procedure shall also be followed for procurement.
