### ORDER :

“e-District” is one of the Mission Mode Projects (MMP) under National e-Governance Plan (NeGP), with the Department of Electronics and Information Technology (DeitY), Government of India as the Nodal Department, to be implemented by State Government or their designated agencies. Tamil Nadu e-Governance Agency (TNeGA) is implementing the State wide roll out of e-District project in our State. This MMP aims at electronic delivery of identified high volume Citizen-centric services, at the Districts through the e-Sevai (CSC) Centres.

2. Based on the administrative approval given by Government of India vide reference 1<sup>st</sup> read above, the Government of Tamil Nadu have issued enabling orders for the State wide Rollout of e-District Project in the remaining 26 districts of the State vide G.O. 2<sup>nd</sup> read above.

3. In the letter 3<sup>rd</sup> read above, the Director, DeitY, Government of India has communicated the revision in the funding pattern of the Schemes under NeGAP and has requested the Government of Tamil Nadu to express the willingness of the State for the revision in the funding pattern.

4. Accordingly, in the letter 4<sup>th</sup> read above, the Government of Tamil Nadu has agreed to the proposal of Government of India for continuation of the scheme under NeGAP with the revised funding pattern of 50:50 by the State and the Centre (i.e 50% of the cost would be met from the State fund).

5. In the Government order 5<sup>th</sup> read above, an amount of Rs. 5,56,00,000/- (Rupees Five crore and fifty six lakh only) has been released as State share to Tamil Nadu e-Governance Agency towards implementation of e-District MMP in the State.

6. In the letter 6<sup>th</sup> read above, among other things the CeG/CEO, TNeGA has sent a proposal to Government seeking release of the balance of the State share of Rs.19.5221 Crore for the implementation of e-District MMP in the State.

7. The Government after careful examination of the above proposal of the Commissioner of e-Governance and Chief Executive Officer, Tamil Nadu e-Governance Agency hereby accord sanction and release a sum of Rs. 19,52,21,000/- (Rupees Nineteen crore fifty two lakhs and twenty one thousand only) as State share to Tamil Nadu e-Governance Agency towards implementation of the e-District MMP in the State.

8. The expenditure sanctioned in paragraph 7 above shall be debited to the following Head of Account:-

"2852.Industries – 07. Telecommunication and Electronic Industries-800. Other Expenditure – UA Assistance towards State Data Centre / Tamil Nadu Wide Area Network/ National e-Governance Action Plan (NeGAP) – 09 Grants-in-Aid – 03 Grants for Specific Schemes (DPC 2852 07 800 UA 0932)"

9. The Section Officer (Bills), Information Technology Department is authorised to draw and disburse the amount sanctioned in paragraph 7 above to the Commissioner of e-Governance & Chief Executive Officer, Tamil Nadu e-Governance Agency (TNeGA) through Electronic Clearing System (ECS) to the TNeGA's Bank Account No.6053284168 held in the Indian Bank, Tamil Nadu Open University branch with IFSC Code: IDIB 000T146 and MICR Code: 600019228.

10. The Commissioner of e-Governance & Chief Executive Officer, Tamil Nadu e-Governance Agency (TNeGA) is requested to send the physical and financial progress of the scheme every month to the Government along with the details of expenditure incurred and Utilization Certificate. Unspent balance, if any, should be remitted into Government account.
