ORDER:

The Hon'ble Chief Minister of Tamil Nadu, among other things has made the following announcement under Rule-110 in the floor of Legislative Assembly on 01.06.2018:-

"தொழில்முனைவோர்களுக்கு தகவல் தொழில் நுட்பவியல் மற்றும் அதனைச் சார்ந்த வணிகத்தை தொடங்க ஏதுவாக, கோயம்புத்தூர் மாவட்டம், விளாங்குறிச்சியில் உள்ள எல்கோசெஸ்ஸில் 2 இலட்சத்து 50 ஆயிரம் சதுர அடி பரப்பளவில் 100 கோடி ரூபாய் மதிப்பீட்டிலும் மற்றும் திருச்சியில் ஒரு இலட்சம் சதுர அடி பரப்பளவில் 40 கோடி ரூபாய் மதிப்பீட்டிலும், இரண்டு தகவல் தொழில்நுட்பக் கட்டடங்கள் கட்டப்படும்."

- 2. Based on the above announcement, in the letters 3rd, 4th, 5th, 6th and 7th read above, the Managing Director, Electronics Corporation of Tamil Nadu Limited (ELCOT) has sent a detailed proposal, seeking administrative approval for construction of 2,66,710 sq.ft IT building at an estimated cost of Rs.114.16 crore in ELCOSEZ Vilankurichi, Coimbatore and another proposal for construction of 1,16,064 sq.ft IT building at an estimated cost of Rs.48.10 crore in ELCOSEZ-Navalpattu, Trichy out of its own funds. The Board of ELCOT and Project Investment Committee (PIC) have approved the above proposal.
 - 3. The salient features of the proposal are as follows:

A. 2.66 lakh sq.ft IT building at ELCOSEZ -Vilankurichi, Coimbatore:

ELCOT has earmarked 2 acres of land in ELCOSEZ for the proposed construction of IT Tower (Basement 2 level + Ground + 5 floors) with 2,66,710 sq.ft IT space in the IT Building.

- 4. The Government after careful examination of the above proposal of the Managing Director, ELCOT, accord administrative approval to Electronics Corporation of Tamil Nadu Limited (ELCOT) for construction of 2,66,710 sq.ft. IT building at an estimated cost of Rs.114.16 crore in ELCOSEZ-Vilankurichi, Coimbatore and for the construction of 1,16,064 sq.ft. IT Building at an estimated cost of Rs.48.10 crore in ELCOSEZ-Navalpattu, Trichy from its own funds subject to the following conditions:
 - i. ELCOT should undertake the construction work by Public Works Department wing of Government of Tamil Nadu.
- ii. ELCOT should ensure structural safety of such high rise structures.
- iii. ELCOT should ensure the structural stability certificate signed by the designated Structural Engineers are obtained wherever necessary.

- iv. ELCOT should ensure that the development control rules are not violated in a manner that could endanger not only the lives of its occupants but also neighbours.
- v. ELCOT should explore the possibilities of constructing such high-rise buildings to be energy efficient solar / green buildings and at the same time Tamil Nadu Transparency in Tenders Act and Tender Rules / PWD schedule of rates are strictly followed wherever necessary.
- vi. ELCOT shall look to provide plug and play services which are preferred now.
