ORDER:

In the reference 1st read above, the Government have constituted a Staff Rationalisation Committee to evaluate the staff structure in various Departments and identify non-essential posts so as to reduce the revenue expenditure and also identify the categories of posts which can be outsourced or appointed through contract appointment for an initial period as a measure to control expenditure.

In the reference 2nd read above, the Secretary (Expenditure) / Member-Secretary, Staff Rationalisation Committee has stated that during the all Secretaries Meeting held on 30.05.2018 at Secretariat, it was decided to form a Sub-Committee to support the Staff Rationalisation Committee as requested by the Chairman, Staff Rationalization Committee by identifying 3-4 competent Officers who are familiar with e-Governance initiative and have introduced e-Office administration in their Departments so as to support the Staff Rationalisation Committee.

3. Accordingly, the Secretary (Expenditure) / Member-Secretary, Staff Rationalisation Committee has requested Information Technology Department to consider and constitute the Sub-Committee to support the Staff Rationalization Committee.
