ORDER:

In the Government Order 1st read above, orders were issued according administrative approval to Electronics Corporation of Tamil Nadu Limited (ELCOT) for upgrading the Tamil Nadu State Data Centre (TNSDC) at a cost of Rs.40.00 crores (Rupees forty crores only) and financial sanction for a sum of Rs.10.00 crores (Rupees ten crores only) to ELCOT for the 1st year operations of TNSDC - Phase II.

- 2. In the Government Order 2nd read above, a sum of Rs.5,83,00,000/- was released to ELCOT towards first instalment for 2nd year operations of TNSDC Phase –II.
- 3. In the Government Order 3rd read above, a sum of Rs.10,00,00,000/- was sanctioned towards second instalment for Phase –II 2nd year operations of TNSDC.
- 4. In the Government Order 4th read above orders have been issued according administrative approval for upgradation of TNSDC (TNSDC-2) at a revised project outlay of Rs.74.6986 crore.
- 5. In the letter 5th read above, the Managing Director, ELCOT has sent a proposal to Government for release of the balance amount of Rs.17,03,00,000/towards 2nd year operations of TNSDC Phase –II.

- 6. The Government after careful examination have decided to accept the proposal of the Managing Director, Electronics Corporation of Tamil Nadu Limited (ELCOT) in paragraph 5 above and sanction a sum of Rs. 16,90,00,000/- (Rupees sixteen crore and ninety lakh only) towards Phase –II 2nd year operations of TNSDC and the balance amount may be met out from the fund provided in BE 2019-2020.
- 7. The expenditure sanctioned above shall be debited to the following head of account:
 - 2852- Industries- 07 Telecommunication and Electronic Industries 800- Other Expenditure- State's Expenditure JM Assistance from State towards establishment of State Data Centre 09 Grants—in—Aid 03 Grants for Specific Schemes (DPC 2852 07 800 JM 0939)
- 8. The amount sanctioned in paragraph 6 above shall not be paid in cash but credited to the following head of account through Cheque in favour of Personal Deposit account of the Electronics Corporation of Tamil Nadu Limited.

- 9. The Section Officer (Bills), Information Technology department is authorized to draw and disburse the amount sanctioned in paragraph 6 above to ELCOT. The Managing Director, ELCOT is authorized to take appropriate measures as necessary for the successful implementation of the project in consultation with the Board. The Managing Director, ELCOT is also directed to send the physical and financial progress report of the project every month to the Principal Secretary to Government, Information Technology Department along with the details of expenditure and Utilisation Certificate.
- 10. This order issues with the concurrence of Finance (Industries) Department vide U.O. No. 11778/Ind./2019, dated 21.03.2019.
