ORDER

In the Government Order first read above, administrative approval was accorded for the creation of an integrated "Tamil Nadu Geographical Information System" (TNGIS) at a total estimated cost of Rs.1,32,80,000/-(Rupees one crore thirty two lakhs and eighty thousand only) towards capital expenditure under Phase-I. The cost break-up details are as below:

In the Government Order second read above, financial sanction was accorded to Tamil Nadu e-Governance Agency for a sum of Rs.61,40,000/- and in the Government order third read above, financial sanction was accorded to Tamil Nadu e-Governance Agency for a sum of Rs.61,40,000/-, totaling Rs.1,22,80,000/- (Rupees one crore twenty two lakhs eighty thousand only) has been sanctioned so far for the

implementation of TNGIS Project with a direction that the remaining amount will be released based on the utilization and justification for the project by Chief Executive Officer, Tamil Nadu e-Governance Agency.

- 3. In the letters fourth read above, the Commissioner of e-Governance and Chief Executive Officer, Tamil Nadu e-Governance Agency has requested the Government to revise the administrative approval accorded in the Government Order first read above and has also requested additional sanction for the items of expenditure, i.e. Software (Licenses and Upgradation), Application Security Audit, Infrastructure Cost and Manpower Cost for Application Development. The Training Cost originally approved at Rs.10,00,000/- to be retained. He has therefore requested for revised administrative approval to an estimated cost of Rs.2,12,80,000/- towards the implementation of Tamil Nadu Geographical Information System (TNGIS) Project and for sanction and release of the balance amount of Rs.90,00,000/- (Rupees ninety lakhs only) (i.e. additional approval and sanction of Rs.80 lakhs + Training cost of Rs.10 lakhs originally approved) in order to continue the GIS activities. The Commissioner of e-Governance and Chief Executive Officer, Tamil Nadu e-Governance Agency has also furnished Utilization Certificate for an amount of Rs.1,08,86,079/- being the expenditure incurred towards TNGIS Project for the period upto October 2017.
- 4. The details of amount already sanctioned, and the requirement of revised sanction sought by the Commissioner of e-Governance and Chief Executive Officer, Tamil Nadu e-Governance Agency under each item of expenditure is detailed below:-

- 5. The Government, after careful examination of the proposal of the Commissioner of e-Governance and Chief Executive Officer, Tamil Nadu e-Governance Agency, hereby accord revised administrative approval for an estimated cost of Rs.2,12,80,000/- (Rupees two crores twelve lakhs and eighty thousand only) and also sanction & release of a sum of Rs.90,00,000/- (Rupees ninety lakhs only) (i.e. the unreleased Training Cost of Rs.10 lakhs + Rs.80,00,000/- from the revised administrative approval) to Tamil Nadu e-Governance Agency towards the implementation of Tamil Nadu Geographical Information System (TNGIS) Project.
- 6. The expenditure sanctioned in paragraph 5 above shall be debited to the following Head of Account:
 - "2852. Industries 07. Telecommunication and Electronic Industries 800. Other Expenditure State's Expenditure JS. Creation of an Integrated Tamil Nadu Geographical Information System 09. Grants-in-Aid 03. Grants for Specific Schemes " (DPC. 2852-07-800-JS-0937)
- 7. Necessary additional funds will be provided in RE/FMA 2018-2019 to meet the expenditure sanctioned in para-5 above. However, this expenditure shall be brought for the notice of the Legislature by Specific Inclusion in the Supplementary Estimates 2018-2019. Pending provision of such funds, the Commissioner of e-Governance is authorized to draw and disburse the amount to Tamil Nadu e-Governance Agency authorized in para 5 above. The Commissioner of e-Governance directed to include this item of expenditure while sending the budget proposal for RE/FMA 2018-2019 and also send necessary draft explanatory note for inclusion of this expenditure in the Supplementary Estimate 2018-2019 to Government in Finance (Industries / BG.II) Department at the appropriate time without fail.
- 8. This order issues with the concurrence of Finance (Industries) Department vide its U.O. No.48080/Finance (Industries)/2018, dated 04.10.2018 and Additional Sanction Ledger No.1497(One thousand four hundred and ninety seven).
