ORDER:

The then Hon'ble Chief Minister of Tamil Nadu, among other things, made the following announcement on 23.09.2016:-

"தமிழ்நாடு 2004–05ஆம் மின்னனு நிறுவனம் கடந்த ஆண்டு சென்னை சோழிங்கநல்லூரில் ஒரு 'எல்கோSEZ' (ELCOSEZ)-ഇ நிறுவியது. த**்**போது சோழிங்கநல்லுார் எல்கோSEZ 45,000 இளைஞர்களுக்கு நேர்முக வேலைவாய்ப்பையும் 90,000 இளைஞர்களுக்கு மறைமுக வேலைவாய்ப்பையும் ஏற்படுத்தியுள்ளது. சோழிங்கநல்லூார் 'எல்கோSEZன்' தகவல் தொழில் நுட்பவியல் மற்றும் தகவல் தொழில் நுட்பவியல் சார்ந்த ஏற்றுமதியின் மதிப்பு 16,536 கோடி ரூபாய் ஆகும். இது, தமிழ்நாட்டில் உள்ள அனைத்து சிறப்பு பொருளாதார மண்டலங்களின் ஏற்றுமதியில் 25 சதவீதமாகும். சிறு மற்றும் குறு தொழில் முனைவோர்கள் தகவல் தொழில் நுட்பவியல் மற்றும் தகவல் தொழில் நுட்பவியல் சார்ந்த வணிகத்தை சென்னையில் தொடங்க ஏதுவாக, சென்னை சோழிங்கநல்லூரில் உள்ள எல்கோSEZல், 2 லட்சம் சதுர அடி பரப்பளவில், தகவல் தொழில் நுட்ப கட்டடம் ஒன்றினை 80 கோடி ரூபாய் மதிப்பீட்டில் கட்டப்படும்."

2. Consequent to the above announcement, in the letters 4th read above, the Managing Director, Electronics Corporation of Tamil Nadu Limited (ELCOT) has sent a detailed proposal, seeking administrative approval for construction of an Information Technology (IT) Tower (Ground + Nine floors) measuring 2.33 lakh sq.ft. and

24,130 sq.ft. for stilt floor in an extent of 2 acres of land located at Plot No.9, ELCOSEZ Sholinganallur, Chennai at an estimated cost of Rs.84.42 crore (Rupees eighty four crore and forty two lakh only) (inclusive of land cost) from out of its own funds.

- 3. The salient features of the proposal are as follows:
 - i. ELCOT has established an ELCOSEZ at Sholinganallur, Chennai to carry out IT and IT enabled services (ITES). This Special Economic Zone (SEZ) became operational during 2008. In Chennai, only a few SEZs have been promoted by realtors and still high demand persists for built up space for IT Sector. In order to capture the demand, ELCOT, as a developer has now proposed to construct an IT Tower and to let it out to the entrepreneurs for setting up of IT / ITES in the SEZ area.
 - ii. In this ELCOSEZ, ELCOT has earmarked 2 acres of land for construction of the proposed IT Tower of Ground + Nine Floors in an area measuring about 2.33 lakh Sq.ft. for IT space and 24,130 sq.ft. for stilt floor. The cost of the project has been estimated as Rs.84.42 Crore including the land cost as detailed below:

- iii. ELCOT has proposed to meet out the above construction cost of Rs.83.42 Crore from out of its own funds (i.e. by utilizing the fixed deposits held by the Company in Banks / Financial Institutions).
- 4. The Government, after careful examination of the above proposal of the ELCOT and with the approval of the members of the Project Investment Committee, accord administrative approval to Electronics Corporation of Tamil Nadu Limited (ELCOT) for construction of an Information Technology (IT) Tower (Ground + Nine floors) measuring 2.33 lakh sq.ft. and 24,130 sq.ft. for stilt floor, in an extent of 2 acres of land located at Plot No.9, ELCOSEZ Sholinganallur, Chennai at an estimated cost of Rs.84.42 crore (Rupees eighty four crore and forty two lakh only) (inclusive of the land cost), from out of its own funds.
 - 5. The Chairman and Managing Director, ELCOT is directed,
 - i. to take effective steps to implement the project in a time bound manner and within the estimated cost,
 - ii. to achieve the maximum permissible Floor Space Index (FSI) for construction of IT Tower with Ground + Nine floors and stilt floor within the estimated cost.
 - iii. to ensure that the actual income tax benefits provided to ELCOSEZ, for this project be claimed and
 - iv. to carry out effective marketing strategies to achieve higher occupancy rate as compared to the projected level so as to reduce the Payback period.
- 6. This order issues with the concurrence of Finance (Industries) Department, vide its U.O.No.48271/Ind/2017, dated 06.10.2017.
