ORDER:

In the Government Order 1st cited, orders were issued constituting two Committees namely a High Level Security Governance Committee (SGC) and a Technical Committee for Security Governance.

In the letter 2nd cited, the Additional Director General of Police (ADGP), Crime Branch Criminal Investigation Department (CBCID) has sought for certain clarification as to whether the Superintendent of Police, CBCID, Cyber Cell (or) the Deputy Commissioner of Police, Cyber Crime Cell is a member in the Technical Committee.

3. In the letter 3rd cited, the Additional Director General of Police (ADGP) was requested to suggest a technically qualified person for the Technical Committee who will act as a single point of contact to handle the issues relating to Cyber Security at the State level.

4. In the letter 4th cited, the Additional Director General of Police (ADGP) has suggested that Thiru Aravind, Additional Superintendent of Police (ADSP), Narcotics Intelligence Bureau (NIB) Criminal Investigation Department (CID) OD, @ CBCID, Cyber Crime Cell, Chennai may be nominated as a member in the Technical Committee for Security Governance. In the Co-ordination meeting held on 21.11.2016, it was suggested that the General Manager (IT Infrastructure), ELCOT may be nominated as the Co-convener for the Technical Committee.

5. The Government, after careful examination of the above, issue the following amendment to G.O. (D) No.25, Information Technology (B4) Department, dated 2.11.2016:-


