ORDER:

In the letter read above, the Chairman and Managing Director, ELCOT has requested to sanction a sum of Rs.81,49,039/- (Rupees eighty one lakh forty nine thousand and thirty nine only) to ELCOT towards provision of 1 Gbps Leased Line Connectivity from National Informatics Centre (NIC), Besant Nagar to Secretariat, for the period from 01.09.2016 to 31.08.2018.

- 2. The Government, after careful examination of the proposal of ELCOT accord sanction for a sum of Rs.60,92,170/- (Rupees sixty lakh ninety two thousand one hundred and seventy only) to ELCOT for provision of 1 Gbps Leased Line Connectivity from National Informatics Centre (NIC), Besant Nagar to Secretariat, for the period from 01.09.2016 to 28.02.2018 subject to the condition that "reduction in the tariff of BSNL, if any due to policy changes, the resultant benefits of cost reduction, if any, need to be extended to ELCOT and the cost may be saved in that case scenario".
- 3. The expenditure sanctioned in paragraph 2 above shall be debited to the following head of Account:-
 - "2852 Industries 07 . Telecommunication and Electronic Industries 800. Other expenditure State's Expenditure JD. Assistance to ELCOT towards Tamil Nadu State Wide Area Network 09. Grants-in-Aid 01- Grants for Current Expenditure." (DPC 2852-07-800-JD-0919).
- 4. The amount sanctioned in paragraph 2 shall not be paid in cash but credited to the following head of account through Electronic Clearing System (ECS) in favour of Personal Deposit account of the Electronics Corporation of Tamil Nadu Limited.

- 5. Necessary funds will be provided in FMA, 2017-2018. Pending provision of such funds, the Section Officer (Bills), Information Technology Department is authorised to draw and disburse the amount sanctioned in paragraph 2 above to the Personal Deposit account of Electronics Corporation of Tamil Nadu Limited. However, this expenditure shall be brought to the notice of the Legislature by an inclusion in the Supplementary Estimates 2017-2018. The Deputy Secretary to Government, Information Technology Department shall include this amount while sending the proposal for FMA 2017-2018, and send necessary draft explanatory note for inclusion of this expenditure in the Supplementary Estimates 2017-2018 to Finance (Industries) Department at the appropriate time without fail.
