ORDER

In the Government Order first read above, administrative approval has been accorded for a sum of Rs.82,79,00,000/- to ELCOT towards phase-I Term II operations (Operations and Maintenance) of Tamil Nadu State Data Centre (TNSDC).

- 2. In the Government Order 2^{nd} read above, a sum of Rs.4,17,00,000/- was released to ELCOT for the TNSDC gap period operations for the period from 01.08.2016 to 30.04.2017.
- 3.In the Government Order 3rd read above a sum of Rs.32,36,000/ was released to ELCOT for the TNSDC 4th quarter gap period (from 01.05.2017 to 31.07.2017) operations and the first year operation of TNSDC Phase-I Term-II.
- 4. In the Government Order 4th read above a sum of Rs.13,04,00,000/ was released to ELCOT towards the 2nd year Operation and Maintenance of TNSDC Phase-I Term-II for the period from 01.05.2019 to 30.04.2020.
- 5. In the letter 5th read above, the Managing Director, ELCOT has requested the Government to release an amount of Rs.11.59 crores for the 3rd year O&M of TNSDC Phase Term-II from 01.05.2020 to 30.04.2021.

- 6. The Government after careful examination of the proposal of the Electronics Corporation of Tamil Nadu Limited have decided to sanction a sum of Rs.11.59 crore (Rupees Eleven crore fifty nine lakh only) for the 3rd year O&M of TNSDC Phase -1 Term-II from 01.05.2020 to 30.04.2021.
- 7. The expenditure sanctioned in paragraph 6 above shall be debited to the following head of account.

9. Necessary additional funds of Rs.8,60,721/- will be provided in FMA 2020-2021 to meet the expenditure sanctioned in paragraph 6 above. However, this expenditure shall be brought for the notice of the Legislature by Specific Inclusion in the Supplementary Estimate 2020-2021. Pending provision of such funds, the Section Officer (Bills), Information Technology Department is authorized to draw and disburse the amount sanctioned in paragraph 6 above to ELCOT through ECS. The Section Officer (Bills), Information Technology Department is also directed to include this item of expenditure while sending the budget proposal for FMA 2020-2021 and also send necessary draft explanatory note for inclusion of this expenditure in the Supplementary Estimate 2020-2021 to Government in Finance (Industries) Department at the appropriate time without fail.

The Managing Director, ELCOT is directed to send the physical and financial progress report of Tamil Nadu State Data Centre (TNSDC) project every month to the Additional Chief Secretary to Government, Information Technology Department along with the details of expenditure and Utilization Certificate.
- 11. This order issues with the concurrence of Finance (Ind) Department vide its U.O.No.5520/Fin(ind)/2020, dated 16.02.2021 and Additional Sanctioned Ledger No.1763 (one thousand seven hundred and sixty three).
