- 3. In the Government Order 3^{rd} read above, a sum of Rs.4.50 Crore has been released towards 2^{nd} year operations of Tamil Nadu Disaster Recovery Centre (TNDRC).
- 4. In the letter 4th read above, the Managing Director, Electronic Corporation of Tamil Nadu Limited (ELCOT) has sought for release of a sum of Rs.10,00,00,000/(Rupees ten crore only) towards the 3rd year operations of Tamil Nadu Disaster Recovery Centre (TNDRC) along with the remaining capex and additional expenditure.
- 5. The Government after careful examination of the proposal of the Managing Director, Electronics Corporation of Tamil Nadu Limited (ELCOT) hereby sanction and release a sum of Rs.6,47,00,880/- (Rupees six crore forty seven lakh and eight hundred eighty only) towards the 3rd year operations of Tamil Nadu Disaster Recovery Centre (TNDRC).

6. The expenditure sanctioned in paragraph 5 above shall be debited under the following head of account:
