ORDER:

In the reference 1st read above, the Ministry of Electronics & Information Technology (MeitY), Government of India (GOI) has approved a new scheme titled **“Pradhan Mantri Gramin Digital Saksharta Abhiyan (PMGDISHA)”** which aims to make six crore persons in rural areas across the State digitally literate, reaching to around 40% of rural households by covering one member from every eligible household in a span of three years.

2.Taking cognizance of the above scheme, the Hon'ble Minister for Information Technology has made an announcement during the Budget Session 2017-2018 that **“IT training would be imparted to 26.79 lakh digitally illiterate Rural Public at a cost of Rs.80.37 crore”** as a part of **Pradhan Mantri Gramin Digital Saksharta Abhiyan (PMGDISHA)** Scheme.

3. In the reference 3rd read above, the Commissioner of e-Governance / Chief Executive Officer, Tamil Nadu e-Governance Agency has sent the detailed proposal for implementation of Pradhan Mantri Gramin Digital Saksharta Abhiyan (PMGDISHA) Scheme in the State. In his proposal, among other things, the Commissioner of e-Governance / Chief Executive Officer, Tamil Nadu e-Governance Agency has requested for formation of a State Level Committee to monitor the implementation of PMGDISHA Scheme in the State. The Commissioner of e-Governance / Chief Executive Officer, Tamil Nadu e-Governance Agency has further stated that as per the instructions of Tamil Nadu e-Governance Agency, District Level Committee (DLC) have been formed with District Collector as Chairman (except Chennai) for monitoring the implementation of the Scheme at ground level.

4. In the meanwhile, in Government order 4th read above, administrative sanction was accorded to Tamil Nadu e-Governance Agency for imparting Information Technology training to 26.79 lakh digitally illiterate Rural Public in the State of Tamil Nadu at an estimated cost of Rs.99,65,88,000/- (Rupees ninety nine crore sixty five lakh and eighty eight thousand only) under Pradhan Mantri Gramin Digital Saksharta Abhiyan (PMGDISHA) Scheme.

5. The Government after careful examination hereby constitutes the State Level Committee with the following composition to monitor the implementation of PMGDISHA Scheme in the State.

1.	Principal Secretary to Government, Information Technology Department	Chairman
2.	Additional Chief Secretary to Government, Rural Development and Panchayat Raj Department or his representative (DRD)	Member
3.	Principal Secretary to Government, Department, School Education or his representative (HOD)	Member
4.	Principal Secretary to Government, Social Welfare and Nutritious Meal Programme Department or his representative (HOD)	Member
5.	Commissioner of e-Governance, State Implementing Agency (SIA)	Member
6.	State Informatics Officer, National Informatics Centre (NIC)	Member
7.	State Coordinator, CSC-SPV	Member
8.	Deputy Secretary, Information Technology Department	Member Secretary

5. The above Committee shall regularly monitor and steer the implementation of the PMGDISHA scheme in the State. The Government further directs the Commissioner of e-Governance/Chief Executive Officer, Tamil Nadu e-Governance Agency to take necessary steps to organize periodical meeting of the State Level Committee at least once in two months to oversee the implementation of the Scheme.
