### ORDER:

Government Services as well as other private services are provided to the common man through Common Service Centres (CSCs) run by Primary Agriculture Co-operative Credit Societies (PACCS), Village Poverty Reduction Committee under Pudhu Vazhvu Project (VPRC), Tamil Nadu Arasu Cable TV Corporation Ltd (TACTV) Centres and Electronics Corporation of Tamil Nadu (ELCOT) Centres. At present, 5 Revenue Schemes, 6 Social Welfare Schemes and 8 Scholarship schemes for Students (educational assistance) are available in e-District portal as a single window system managed through Common Service Centres (CSCs).

- 2. In the letter read above, the Director, e-Governance/ CEO,TNEGA has requested that implementation and functioning of CSCs need to be monitored closely and problems/difficulties faced by CSCs need to be addressed, as and when it arises and therefore has sent a proposal for constitution of a State Level Coordination Committee for Common Service Centres.
- 3. After careful examination, the Government have decided to accept the above proposal and here by constitute a State Level Coordination Committee for Common Service Centres (CSCs) with the following composition:-

The Committee will meet at least once in a month (or) as and when required to discuss the issues relating to the implementation/ functioning of Common Service Centres (CSCs). The Committee will also monitor the implementation and functioning of CSCs and send necessary recommendations / suggestions to the concerned Agencies/Departments to resolve the problems/difficulties faced by Common Service Centres (CSCs).
