ORDER

2. In the Government order 2nd read above a sum of Rs. 4,17,00,000/- was released to ELCOT for the TNSDC gap period operations for the period from 01.08.2016 to 30.04.2017.

3. In the Government order 3rd read above a sum of Rs.32,36,000/ was released to ELCOT for the TNSDC 4th quarter gap period (from 01.05.2017 to 31.07.2017) operations and the first year operation of TNSDC Phase-I, Term-II.

4. In the letter 4th read above, the Managing Director, ELCOT has requested the Government to release a sum of Rs.13.04 crore towards the 2nd year Operation and Maintenance of TNSDC Phase-I Term-II for the period from 01.05.2019 to 30.04.2020.

5. The Government after careful examination of the proposal of the Electronics Corporation of Tamil Nadu Limited (ELCOT) sanction and release a sum of Rs.13,04,00,000/- (Rupees thirteen crore and four lakin only) towards the 2nd year Operation and Maintenance of TNSDC Phase-I Term-II for the period from 01.05.2019 to 30.04.2020.

6. The expenditure sanctioned in paragraph 5 above shall be debited to the following head of account.
