- 3. In the letter 4th read above the Managing Director, ELCOT has requested the Government to release a sum of Rs.21.838 Crore towards the second year operations of TNSWAN Phase 2 Extension Operations for the period from 14.02.2020 to 13.02.2021
- 4. The Government after careful examination have decided to accept the proposal of the Managing Director, Electronics Corporation of Tamil Nadu Limited (ELCOT) in paragraph 3 above and release a sum of Rs.21.838 Crore towards the second year operations of TNSWAN Phase 2 Extension Operations for the period from 14.02.2020 to 13.02.2021.
