### ORDER:

“Capacity Building” is one of the Mission Mode Projects (MMP), with the objective to provide professional resources and training support to political and policy level decision makers. Capacity Building and Knowledge Management programmes have to be done for wide variety of e-Governance Training programmes targeted at different levels in State Government Departments.

2. During the implementation of Capacity Building Phase II project, the Government of India, in the reference 1<sup>st</sup> read above, had requested Government of Tamil Nadu for implementing the Capacity Building phase II project on 50:50 Central and State sharing funding pattern. The Government of Tamil Nadu, in the reference 2<sup>nd</sup> second read above, had agreed to the request of Government of India and confirmed that the 50% of the project cost would be met from the State fund.

3. In the references 3<sup>rd</sup> and 4<sup>th</sup> read above, the Director of e-Governance and Chief Executive Officer, Tamil Nadu e-Governance Agency has sent proposal to Government towards release of State and Central share for Capacity Building Phase-II project as below:

The Director of e-Governance and Chief Executive Officer, Tamil Nadu e-Governance Agency has further stated that the amount released for the Capacity Building Phase II project has been fully utilized and balance amount as on date is "Nil". He has further stated that out of the total project outlay of Rs.3,34,00,000/- for Capacity Building phase II project, funds to be released by Central and State is Rs.1.67 Crores each, in the funding pattern of 50:50. Out of Rs.1.67 Crores towards Central Share, a sum of Rs.30,71,883/- has already been released by Ministry of Electronics and Information Technology, Government of India. Now, the Director of e-Governance and Chief Executive Officer, Tamil Nadu e-Governance Agency has requested the Government to release the State Share of Rs.1,67,00,000/- to implement the Capacity Building Phase II project.

5. The proposal of Director of e-Governance and Chief Executive Officer, Tamil Nadu e-Governance Agency was examined in detail. After careful examination, the Government accord sanction and release the proportionate State Government share of Rs. 30,71,883/- (Rupees Thirty lakh and seventy one thousand eight hundred and eighty three only) to Tamil Nadu e-Governance Agency, against the Central assistance received so far under the Capacity Building Phase II project vide Electronic Fund Transfer dated 13/23 October 2016 (Rs.11,21,883) and dated 30<sup>th</sup> March 2016 (Rs.19,50,000).

6. The expenditure sanctioned in paragraph 5 above shall be debited to the following Head of Account:-

"2852.Industries – 07. Telecommunication and Electronic Industries-800. Other Expenditure – Schemes shared between State and Centre – UA. Assistance towards State Data Centre / Tamil Nadu Wide Area Network/ National e-Governance Action Plan (NeGAP) – 09.Grants-in-Aid – 03.Grants for Specific Schemes (DPC 2852 07 800 UA 0932)

7. The Section Officer (Bills), Information Technology Department is authorized to draw and disburse the amount sanctioned in paragraph 5 above to the Director of e-Governance and Chief Executive Officer, Tamil Nadu e-Governance Agency (TNeGA) through Electronic Clearing System (ECS) to the Tamil Nadu e-Governance Agency Account No. 281801000002605 held in the Indian Overseas Bank, K.B Dasan Salai Branch with IFSC Code: IOBA0002818 and MICR Code: 600020198.

8. The Director of e-Governance and Chief Executive Officer, Tamil Nadu e-Governance Agency (TNeGA) is requested to send the physical and financial progress of the scheme every month to the Government along with the details of expenditure incurred and Utilization Certificate. Unspent balance, if any, should be remitted into Government account.
