ORDER:

The Government of India had notified the Indian Telegraph Right of Way (RoW) Rules, 2016 for establishment of underground infrastructure (Optical Fibre) and overground infrastructure (mobile towers).

2. In the G.O 2nd read above, orders were issued for implementation of the above Rules. In the letter 3rd read above, the Secretary, Department of Telecommunications (DoT), Government of India requested to take necessary action to constitute a Committee chaired by the Chief Secretary and hold quarterly review meetings with the Telecom Service Providers (TSPs)/Infrastructure Providers (IPs) on the progress of towers and fibre installation.

3. The Government after careful examination of the above, hereby constitute a "State Level Telecom Committee" chaired by the Chief Secretary to convene quarterly review meetings with the Telecom Service Providers (TSPs)/Infrastructure Providers (IPs) on the progress of towers and fibre installation with the following composition:-
