ORDER:

In the Government Order 1st read above, an Advisory Committee was constituted for Tamil Nadu Arasu Cable TV Corporation Limited (TACTV), formerly, Arasu Cable TV Corporation Limited, comprising of the following Official and Non-Official Members:-

In the letters 2nd and 3rd read above, the Managing Director, TACTV has stated that the Advisory Committee is found to be redundant in the competitive Cable TV industry which is having a multitude of Cable TV Operators Associations with conflicting claims of representation of the Industry. He has further stated that as TACTV is one of the Multi System Operators (MSOs) in the Country and the Industry comprises various private MSOs also operating in the field, TACTV cannot take on Board any of the Office bearers or representatives of the various Associations in the Industry. Moreover, with considerable operational experience since the revamping of TACTV in 2011, the Advisory Committee is no longer relevant. Taking into consideration of the above facts, the Board of Directors of TACTV in it's 54th meeting held on 20.03.2017 have passed a resolution for dissolution of the Advisory Committee. The Managing Director, TACTV has therefore requested the Government to dissolve the Advisory Committee of TACTV.

3. The Government after careful examination of the request of the Managing Director, TACTV hereby dissolve the Advisory Committee of the TACTV constituted in Government Order 1st read above.

4. This order issues with the concurrence of the Finance (Ind.) Department, vide its U.O. No. 743/Fin(Ind.)/2020 dated 13.01.2020.
