ORDER:

In the G.O 1st read above, orders have been issued constituting a "State Level Telecom Committee" under the chairmanship of the Chief Secretary to Government of Tamil Nadu, to convene quarterly review meetings with the Telecom Service Providers (TSPs)/ Infrastructure Providers (IPs) on the progress of towers and fibre installation wherein the Deputy Director General (DDG), Telecom Enforcement Resource Monitoring (TERM) Cell, Chennai has been nominated as a member.

2. In the letter 2nd read above, the Deputy Director General (Rural), Department of Telecommunications, Government of India has informed that the Telecom Enforcement Resource Monitoring (TERM) Cell is now known as Tamil Nadu Licence Service Area (LSA) and the Right of Way (RoW) and other allied subjects are being handled by the Deputy Director General (Rural) of the LSA concerned as per the allocation of works mandated by Department of Telecommunications (DoT) Head Quarters and has therefore requested for an amendment to the above G.O by renaming the Member of Telecom Department as "Deputy Director General (Rural), Tamil Nadu Licence Service Area (TN LSA), Chennai".

3. The Government after careful examination of the above request decided to accept the same and issue the following Amendment to the G.O first read above.

AMENDMENT

In paragraph 3 of the G.O. (2D) No.4, Information Technology Department, dated 06.07.2019, for the words "Deputy Director General (DDG), Telecom Enforcement, Resource and Monitoring (TERM) Cell, Chennai" as a member, the words "Deputy

Director General (Rural) Tamil Nadu License Service Area, Chennai" as a member shall be substituted .

4. This order does not require the concurrence of Finance Department as per the G.O (Ms.) No.519, Finance (Salaries) Department dated 29.09.1997.




