ORDER:

"Capacity Building" is one of the Mission Mode Project (MMP), with the objective to provide professional resources and training support to political and policy level decision makers. Capacity Building and Knowledge Management programmes have to be done for wide variety of e-Governance Training programmes targeted at different levels in State Government Departments.

- 2. In the reference 1st read above, Government of Tamil Nadu has agreed to the proposal of Government of India for continuation of the scheme under NeGAP with the revised funding pattern of 50:50 by the State and the Centre (i.e 50% of the cost would be met from the State fund).
- 3. In the Government order 2nd read above, an amount of Rs.30,71,883/-has been released towards State share for Capacity Building Phase-II project.
- 4. In the reference 3rd read above, National e-Governance Division (NeGD), Ministry of Electronics and Information Technology (MeitY), Government of India has released the third installment of Rs.20,74,217/- towards the operational expenses for SeMTs under Capacity Building scheme Phase-II.

5. In the reference 4th read above, the Commissioner of e-Governance / Chief Executive Officer, Tamil Nadue-Governance Agency has sent a proposal to Government towards release of State and Central share for Capacity Building Phase-II project as tabulated below:

- 6. So far, out of Rs. 1.67 crore towards Central share, a sum of Rs. 51,46,100/has been released by Ministry of Electronics and Information Technology, Government of India and out of Rs. 1.67 crore towards State share, a sum of Rs. 30,71,883/-has already been released by the State Government. Now, the Commissioner of e-Governance / Chief Executive Officer, Tamil Nadu e-Governance Agency has requested the Government to release the balance amount of Rs. 1,36,28,117/- towards State share to implement the Capacity Building Phase II project and has also requested to address Ministry of Electronics and Information Technology, Government of Indiafor the release of Rs. 1,15,53,900/-towards Government of India Share to implement Capacity Building Phase-II project in the State.
- 7. The Government after careful examination of the above proposal of Commissioner of e-Governance / Chief Executive Officer, Tamil Nadu e-Governance Agency hereby accord sanction and release an amount of Rs.20,74,217/- (Rupees Twenty lakh seventy four thousand two hundred and seventeen only) to Tamil Nadu e-Governance Agency towards State share which is equivalent to the 3rd installment released by Ministry of Electronics and Information Technology, Government of India for Capacity Building Phase-II project.

8. The expenditure sanctioned in paragraph 7 above shall be debited to the following Head of Account:-

The Section Officer (Bills), Information Technology Department is authorized to draw and disburse the amount sanctioned in paragraph 7 above to the Commissioner of e-Governance / Chief Executive Officer, Tamil Nadu e-Governance Agency (TNeGA) through Electronic Clearing System (ECS) to the TNeGA's Bank Account No. 281801000002605 held in the Indian Overseas Bank, K.B Dasan Salai Branch with IFSC Code: IOBA0002818 and MICR Code: 600020198.
- 10. The Commissioner of e-Governance / Chief Executive Officer, Tamil Nadu e-Governance Agency (TNeGA) is requested to send the physical and financial progress of the scheme every month to the Government along with the details of expenditure incurred and Utilization Certificate. Unspent balance, if any, should be remitted into Government account.
