ORDER:

- 2. In the Government Order 2nd read above, a sum of Rs.4,17,00,000/- was released to ELCOT for the TNSDC Gap period operations for the period from 01.08.2016 to 30.04.2017.
- 3. In the letter 3rd read above, the Chairman and Managing Director, ELCOT has requested the Government to release a sum of Rs.32.36 Crore towards the (i) 4th quarter Gap period (from 01.05.2017 to 31.07.2017) operations and (ii) the 1st year operations of TNSDC Phase–I Term II.
- 4. The Government after careful examination of the proposal of the Electronics Corporation of Tamil Nadu Limited (ELCOT) sanction and release a sum of Rs.32,36,00,000/- (Rupees thirty two crore and thirty six lakh only) towards the (i) 4th quarter Gap period (from 01.05.2017 to 31.07.2017) operations and (ii) the 1st year operations of TNSDC Phase –I Term-II by relaxing Quarterly control of Appropriation System for the year 2017-2018 issued in the G.O.(Ms).No.78, Finance (BG-I) Department, dated 30.03.2017.
- 5. The expenditure sanctioned in paragraph 4 above shall be debited to the following head of account:
