ORDER:

In the Government order 1st read above, administrative sanction has been accorded to Tamil Nadu e-Governance Agency for implementation of a portal "namadhuarasu.in" at a cost of Rs.91,80,400/- for a period of two years to enable the common public to share their views with Government.

- 2. In the Government order 2nd read above, Government has accorded financial sanction of Rs.47,95,400/- (Rupees forty seven lakhs ninety five thousand four hundred only) towards first year instalment for implementing the Scheme. Further, the Government has directed the Commissioner of e-Governance and Chief Executive Officer, Tamil Nadu e-Governance Agency (TNeGA) to send necessary proposal seeking financial sanction for 2nd year operations of this project at the appropriate time.
- 3. Accordingly, in the letter 3rd read above, the Commissioner of e-Governance and Chief Executive Officer has sent the proposal and has stated that for continuing the implementation process of "namadhuarasu" in our state, the second year instalment fund is necessary to meet out the following.

- 4. The Commissioner of e-Governance / Chief Executive Officer, Tamil Nadu e-Governance Agency (TNeGA) has therefore requested the Government to sanction the 2nd year instalment fund of Rs.43.85 lakh (Rupees Forty Three lakh and Eighty five thousand only) for implementing the Scheme.
- 5. The Government after careful examination of the proposal of the Commissioner of e-Governance and Chief Executive Officer, Tamil Nadu e-Governance Agency hereby accord financial sanction of Rs. 43.85 lakh (Rupees Forty Three lakh Eighty five thousands only) towards 2nd year instalment for implementing the scheme.
- 6. The expenditure sanctioned in paragraph 5 above shall be debited to the following Head of Account:-

"2852 Industries - 07 Telecommunication and Electronic Industries - 800 Other Expenditure State's Expenditure – AE Grants to Tamil Nadu e-Governance Agency -09 Grants – in –Aid -03 Grants for specific Scheme".
