ORDER:

In the Government Order read above, orders were issued according Administrative Sanction for a sum of Rs.702 Crore allocating fund of Rs.3 Crore per Constituency along with detailed Guidelines for the implementation of Member of Legislative Assembly Constituency Development Scheme (MLACDS) for the year 2023-2024 and financial sanction was accorded for a sum of Rs.351 Crore being 50% of Fund out of Budget Allocation of Rs.702 Crore for the implementation of Member of Legislative Assembly Constituency Development Scheme for the year 2023-2024.

- 2. In the Letter read above, the Director of Rural Development and Panchayat Raj has sent a proposal to Government stating that the Government have sanctioned Rs.702 Crore for the implementation of Member of Legislative Assembly Constituency Development Scheme in the year 2023-24. In this regard, Rs.351 Crore has been released by the Government as 1st installment. The necessary proceedings have been issued by the Director of Rural Development and Panchayat Raj for the drawl of Rs.351 Crore as 1st installment and the bill was presented in the Pay and Accounts Office (South), Chennai.
- 3. He has further stated that the Finance Department (Ways & Means) has instructed to open a Public Deposit Account for the operation of Member of Legislative Assembly Constituency Development Scheme funds. Hence, the funds so far have not been drawn and disbursed to the Districts. In this regard, in the Government Order read above, in Para No.6.1 of Guidelines, it has been mentioned

that the Director of Rural Development and Panchayat Raj shall draw and disburse the fund to all the Districts. Accordingly, upto the previous financial years, the funds have been drawn and deposited in a savings bank account under the Member of Legislative Assembly Constituency Development Scheme.

- 4. The Director of Rural Development and Panchayat Raj has therefore requested the Government for amending the Guidelines (both in English and Tamil) for the implementation of Member of Legislative Assembly Constituency Development Scheme for the year 2023-2024 issued in G.O. (Ms) No.98, Rural Development and Panchayat Raj (SGS-1) Department, dated 19.07.2023 in the caption of "Fund Release and Financial Management" in Para No.6.1.
- 5. The Government have carefully examined the proposal of the Director of Rural Development and Panchayat Raj in detail and decided to amend the Para No. 6.1 of the Guidelines annexed to the G.O. (Ms) No.98, Rural Development and Panchayat Raj (SGS-1) Department, dated 19.07.2023. Accordingly, the following amendment is issued in English and Tamil:-
