### **ORDER:**

In the Government Order read above, orders were issued according Administrative Sanction for a sum of Rs.702 Crore allocating fund of Rs.3 Crore per Constituency along with detailed Guidelines for the implementation of Member of Legislative Assembly Constituency Development Scheme (MLACDS) for the year 2023-2024 and financial sanction was accorded for a sum of Rs.351 as first installment.

2. In the Letter read above, the Director of Rural Development and Panchayat Raj has stated that the Member of Legislative Assembly Constituency Development Scheme fund was drawn and deposited in "Public Deposit Account No – 202309656713. The balance 50% of the Member of Legislative Assembly Constituency Development Scheme fund for the year 2023-24 has to be released to all the District Collectors and the Commissioner of Greater Chennai Corporation. Hence, the Director of Rural Development and Panchayat Raj has requested the Government to issue necessary orders for the release of balance 50% of the fund amounting to Rs.351 crore out of the total allocation of Rs.702 crore under Member of Legislative Assembly Constituency Development Scheme for the year 2023-2024.

3. The Government have carefully examined the proposal of the Director of Rural Development and Panchayat Raj in detail, decided to accept the same and sanction a sum of Rs.351,00,00,000 (Rupees Three Hundred and Fifty One Crore only) being balance of 50% of fund out of Budget Allocation of Rs.702 Crore for the

implementation of Member of Legislative Assembly Constituency Development Scheme for the year 2023-2024 and order accordingly, by relaxing the Quarterly Control of Appropriation for which orders were issued in G.O. (Ms) No.99, Finance (BG-I) Department, dated 31.03.2023 for the heads of accounts mentioned in para 4 below.
