ORDER:-

Every year the Government of India release Special Central Assistance for the Economic Development of Adi Dravidars by implementing Scheduled Caste Sub Plan (SCSP) in the State. The assistance received is transferred to the Personal Deposit Account of the Tamil Nadu Adi Dravidar Housing and Development Corporation Limited (TAHDCO), for implementing Economic Development Schemes for Scheduled Caste by the TAHDCO and also through various other departments.

2. The Government of India in their letter second read above, among others have conveyed the sanction of Rs.34,62,24,000/- (Rupees Thirty Four Crore Sixty two lakhs and Twenty four thousand only) to Government of Tamil Nadu as first instalment of Special Central Assistance to Scheduled Caste Sub Plan for the year 2014-2015. The Government of India have also stated that the Special Central Assistance is an additive to the Scheduled Caste Sub Plan of the States/Union Territories and it should be used only for specific sector-wise, area-wise schemes aimed at income generating development programmes directly relevant to the economic upliftment of Scheduled Caste population in the areas. The Government

of India have further stated that, any unspent balance amount of previous year cannot be carried forward for expenditure during the next financial year but should be adjusted against the amount of Special Central Assistance due to State Government for the current year at the time of release of final instalment of the current year. The Government of India have also requested that the State Government should furnish quarterly progress report on the utilization of Special Central Assistance to the Government of India, Ministry of Social Justice and Empowerment, New Delhi, within 15 days after the end of each quarter, in the prescribed proforma already available with the State Government.

- 3. In the G.O first read above, it has been ordered that 10% of the Special Central Assistance Fund received from the Government of India, as Special Central Assistance to Scheduled Caste Sub Plan shall be released directly to the account of Director of Adi Dravidar Welfare for providing infrastructure facilities to Scheduled Caste habitations and Adi Dravidar Schools/Hostels and the balance 90% shall be released to the Personal Deposit Account of TAHDCO through the Director of Adi Dravidar Welfare for implementing Economic Development schemes for Scheduled Castes through various other departments.
- 4. Accordingly, the Government after careful consideration accord sanction for a sum of Rs.34,62,24,000/- (Rupees Thirty Four Crore Sixty two lakhs and Twenty four thousand only)received from the Government of India as first instalment of Special Central Assistance, to Scheduled Caste Sub Plan for the year 2014-2015.
- 5. The expenditure sanctioned in para 4 above shall be debited to the following Head of Account:-

"2225–Welfare of Scheduled Castes, Scheduled Tribes and Other Backward Classes–01-Welfare of Scheduled Castes–793 Special Central Assistance for Scheduled Caste Component Plan–Schemes in the Twelfth Five Year Plan-III-Centrally Sponsored –SB-Welfare Schemes for Scheduled Castes under Special Component Plan–09- Grants in Aid–09-Others (D.P. Code No.2225-01 793 SB 09 09 98).

6. The Government permit to release a sum of Rs.3,46,22,400/- (Rupees Three Crore Forty six lakhs, Twenty two thousand and Four hundred only) being the 10% of total amount released by Government of India as first instalment of Special Central Assistance to Scheduled Caste Sub Plan for the year 2014-2015 to the Director, Adi Dravidar Welfare for providing infrastructure facilities to Scheduled Caste habitations, Schools and Hostels under Adi Dravidar and Tribal Welfare Department. Out of the 90% balance amount of Rs.31,16,01,600/- (Rupees Thirty one crore sixteen lakhs one thousand and six hundred only), the Government have also released a sum of Rs. 2,90,10,624/- to the Director, Adi Dravidar Welfare to meet out the expenditure of teaching grant sanctioned in G.O(Ms)No.111, Adi Dravidar and Tribal Welfare Department, dated.11.11.2011 for 26 posts in the schools under the control of Muthukaruppan Memorial Educational Trust, Tuticorin District for the years 2012-2013, 2013-2014, and 2014-2015 at the rate of

Rs.85,66,142/-, Rs.97,42,427/- and Rs.1.07,02,055/- respectively. The Government also permit to release a sum of Rs.28,25,90,976/-(Rupees Twenty eight Crores Twenty five lakhs Ninety thousand Nine hundred and Seventy six only) from the balance 90% amount Rs.31,16,01,600/-(Rupees Thirty one crore sixteen lakhs one thousand and six hundred only) of total amount released by Government of India to TAHDCO for the implementation of Economic Development Activities and Skill Development Training Programme for the year of 2014-2015.

7. The sum of Rs.28,25,90,976/-(Rupees Twenty eight Crores Twenty five lakhs Ninety thousand Nine hundred and Seventy six only) be released to TAHDCO in para 6 above shall not be paid in cash but shall be credited to the following head of account by means of an account payee cheque in favour of the Personal Deposits Account of TAHDCO Limited:-

"K Deposits and Advances (b) Deposits not bearing interest-8443-00- Civil Deposits-800 – other Deposits-BY-Deposits of Tamilnadu Adi-Dravidar Housing Development Corporation (TAHDCO), (DPC 8443 00 800 BY 0004) ('out go') (DPC 8443 00 800 BY 000G) (Receipt)

- 8. The Director of Adi Dravidar Welfare, Chennai -5 is authorized to draw the amount sanctioned in para 4 above. He is also authorized to issue the Account Payee Cheque in favour of "Personal Deposit Account" of the Tamil Nadu Adi Dravidar Housing and Development Corporation Limited (TAHDCO) with Account Number and disburse the same to Tamil Nadu Adi Dravidar Housing and Development Corporation Limited, Chennai.
- 9. The Managing Director, Tamil Nadu Adi Dravidar Housing and Development Corporation Limited (TAHDCO) and the Director of Adi Dravidar Welfare are directed to maintain separate accounts for Special Central Assistance funds operated and disbursed by them for the various components separately for every financial year for implementing various Welfare Schemes. The relevant registers for the various disbursements of assistance should be maintained with the complete details of beneficiaries. The Director of Adi Dravidar Welfare and the Managing Director, Tamil Nadu Adi Dravidar Housing and Development Corporation Limited (TAHDCO) should ensure that the funds are utilized for the real purpose and to the actual beneficiaries fully without any shortfall or complaints. If any failure is noticed in this regard severe action will be taken against the Officers, who are responsible for such lapses. The Managing Director, Tamil Nadu Adi Dravidar Housing and Development Corporation Limited (TAHDCO) and the Director of Adi Dravidar Welfare are directed to send the details of expenditure under the Special Central Assistance schemes for each and every month on or before 10th of the succeeding month to the Government.
