The Government of India, Ministry of Welfare, New Delhi have informed this Government in their letter read above that the constitution (Scheduled Castes) orders (Amendment) Act, 1990 which was passed by the parliament and received the assent of the President of India on 3rd June 1990 and published in the Gazette of India on 4.6.90.

2. It has been brought to the notice of this Government that certificate issuing authorities are still not adopting the revised lists and correct names of Scheduled Castes/Scheduled Tribes while issuing the Community Certificate to eligible and genuine persons belonging to Scheduled Castes/Scheduled Tribes. A Copy of the constitution (Scheduled Castes) orders (Amendment) Act 1990 is enclosed, for ready reference.

3. The Collectors and Heads of Departments concerned and the certificate issuing authorities under their control are requested to adopt the list of Scheduled Castes/Scheduled Tribes contained in Central Act 1976 (Central Act 103/76) as already communicated in the Government order read above, and constitution (Scheduled Castes) orders (Amendment) Act

1990 strictly. Any deviation will be viewed seriously.
The receipt of this order shall be acknowledged.


