Order:

The Chief Engineer(AE) has stated that Government of India have earlier sanctioned a sum of Rs.355.23 lakhs (Rs.319.707 lakhs as Government of India share + Rs.35.523 lakhs as Government of Tamilnadu share) towards the implementation of Agricultural Mechanisation Programme as per the work plan approved by the Government of India for the year 2010-11.

2. In the G.O. second read above Government have released an amount of Rs.300.00 lakhs as 1st installment towards the implementation of this scheme. Accordingly an amount of Rs.298.29 lakhs has been utilised upto 31.12.2010 towards the distribution of Tractors, Power tillers and Rotavotors to the farmers.

- 3. In the meantime the Commissioner of Agriculture has sent the Additional Work Plan Proposal for farm Mechanisation and seeking sanction of a sum of Rs.2117.20 lakhs from Government of India. Now, Government of India have released a sum of Rs.1325.00 lakhs as Government of India share as additional allocation for 'Farm Mechanization. The State Government has to release the 10% Government of Tamilnadu's share of Rs.147.22 lakhs.
- 4. In view of the heavy demand from the farmers, the Chief Engineer(Agriculture Engineering) has now sent the proposal in the reference fourth read above for the distribution of following machinery/ implements with subsidy norms prescribed in the Revised Macro Management of Agriculture with a total cost of Rs.1472.20 lakhs.
- i) Tractors upto 40 HP with a subsidy assistance of 25% of the unit cost of Tractor or limited to Rs.45,000/- which ever is less as per the revised guidelines of Government of India.
- ii) Power tillers 8 hp and above with a subsidy assistance of 40% of the unit cost of Power tillers or limited to Rs.45,000/- which ever is less as over the revised guidelines of Government of India.
- iii) Rotavators with a subsidy assistance of 40% of the unit cost of Rotavators or limited to Rs.20,000/- which ever is less as per the revised guidelines of Government of India.
- 5. The programme for the additional outlay of Rs.1472.20 lakhs is as follows:-

6. In this regard the Commissioner of Agriculture who is the Nodal Officer of the Macro management of Agriculture Scheme in his letter in the reference fifth read above has also recommended the proposal.

7. The Government after careful consideration accept the proposal of the Chief Engineer(Agriculture Engineering) and the Commissioner of Agriculture. Accordingly Government sanction is accorded for a sum of Rs.1472.20 lakhs (Rupees One thousand four hundred and seventy two lakhs and twenty thousand only.) additionally towards the distribution of following Machinery/implements with subsidy norms prescribed in the revised Macro Management of Agriculture for implementation of Agricultural Mechanisation programme in TamilNadu.

- 9. The amount sanctioned in para 7 above can be met from the provision made in Final Modified Appropriation/ FSE 2010-11 and the Chief Engineer (Agricultural Engineering) is authorised to incur the Expenditure as sanctioned above.
- 10. The Chief Engineer(Agriculture Engineering) and the Commissioner of Agriculture is directed to follow the guidelines of Government of India in implementing the schemes without any deviation.
- 11. The Commissioner of Agriculture and Chief Engineer (Agricultural Engineering) are directed to issue suitable executive instructions to the Officers //pto//

concerned for the implementation of the schemes.

- 12. The Chief Engineer (Agricultural Engineering) is permitted to draw the funds sanctioned above.
- 13. The Chief Engineer (Agricultural Engineering) is requested to send consolidated Monthly / Quarterly / Annual Progress Reports and Utilization Certificates to the Commissioner of Agriculture, Chennai-5, who in turn will consolidate and send them to Government for onward transmission to Government of India, Ministry of Agriculture, Department of Agriculture & Cooperation, New Delhi.
- 14. This order issues with the concurrence of the Planning Development and Special Initiatives and Finance Departments vide their U.O.No.912 /Central Sector Scheme/11, dated:08.02.2011 and U.O.No 7/Under Secretary to Government(PU)/Agriculture/11, dated: 23.02.2011 respectively.
