ORDER:-

In the G.O first read above, among others, orders were issued according sanction for the implementation of "Creation of Seed Infrastructure Facilities" (construction of 95 seed storage godowns each of 1000 MT capacity) under the Central Sector Scheme "Development and strengthening of Infrastructure Facilities for Production and Distribution of Quality Seeds" at a cost of Rs.1125.00 lakhs during 2009 – 2010.

2. In the G.O second read above sanction was accorded for a sum of Rs.837.00 lakhs, being second instalment for utilization during

- 2010 2011 for completion of the construction of seed storage godowns under "Creation of Seed Infrastructure Facilities" component of Central Sector Scheme "Development and Strengthening of Infrastructure Facilities for Production and Distribution of Quality Seeds" and also permitted the Commissioner of Agriculture to change the programme of construction of 95 godowns to 79 godowns.
- 3. The Commissioner of Agriculture, in his letter fourth read above has now reported that out of Rs.1125.00 lakhs sanctioned in the G.O. first read above under "Creation of Seed Infrastructure Facilities" during 2009 2010 for the construction of seed storage godowns, only Rs.2,18,91,000/- has been incurred by the Chief Engineer (Buildings), Public Works Department and the balance of Rs.906.09 lakhs has been surrendered. The Commissioner of Agriculture has therefore requested the Government to sanction the above unspent amount of Rs.906.09 lakhs for utilization during 2010 2011.
- 4. The Government of India in their letter third read above has also revalidated the unspent amount of Rs.906.09 lakhs for utilization during 2010 2011. The Government of India have also permitted the implementing agency to utilize the interest accrued on the Grants –in-aid for completing remaining construction work of seed storage godown during 2010 2011.
- 5. The Government, after careful consideration accord sanction for a sum of Rs.906.09 lakhs (Nine crore six lakhs and nine thousand only) as revalidated by Government of India for utilization during 2011 2012 for completing remaining work of construction of 79 Seed Storage godowns under Creation of Seed Infrastructure Facilities of Central Sector Scheme "Development and Strengthening of Infrastructure Facilities for Production and Distribution of Quality Seeds.
- 6. The Commissioner of Agriculture is directed to utilize the interest accrued on the grants -in aid, if any, for completing remaining construction work of seed storage godowns.
- 7. The Expenditure sanctioned in para 5 above shall be debited to the following head of account:-

[&]quot; 4401 - 00 - Capital Outlay on Crop Husbandry - 103 - Seeds - Schemes in the Eleventh Five Year Plan - III Centrally Sponsored SA Construction of Agricultural Seed Godowns - 16 Major Works" (DPC 4401 - 00 - 103 - SA -1608).

- 8. The Commissioner of Agriculture is directed to follow the terms and conditions stipulated by the Government of India vide their Letter No.10-10/2009-SDVI, dated 14.7.2009 and also instructions issued in Government of India's letter No.10/1/2006, SD VI, dated 23.12.2010, while implementing the scheme.
- 9. The Commissioner of Agriculture is requested to send the actual final physical progress report indicating location wise seed storage godown established along with expenditure incurred and seed storage capacity created in the prescribed proforma and utilization certificate in GFR 19 (A) to Government of India and Government.
- 10 This order issues with the concurrence of Finance Department vide its U.O. No. 36836/Agri/2011, dated 22.7.2011.
