ORDER:-

In the reference first read above Government of India have given budget allocation for Rs.3085.86 lakhs for implementation of Macro Management of Agriculture scheme and requested to send necessary proposal in this regard. In the reference second read above, the Commissioner of Agriculture has sent a proposal for a sum of Rs.9645.780 lakhs for approval of Government of India.

2. Government of India however in the reference third read above, have given approval for a s sum of Rs.3134.92 lakhs for implementation of the Macro Management of Agriculture Scheme during 2011-12. In the reference 4th read above, Government of India have released a sum of Rs.1388.635 lakhs as its first instalment for the implementation of Macro Management of Agriculture Scheme during 2011-12.

3. The Commissioner of Agriculture in his letter 6th read above has requested the Government to accord administrative sanction for a sum of Rs.3134.920 lakhs and sanction a sum of Rs.1746.287 lakhs (Government of India Share Rs.1388.635 lakhs + Revalidation of unspent amount of Rs.44.16 lakhs, State entire Share Rs.313.492 lakhs) as first instalment for implementation of Macro Management of Agriculture Scheme during 2011-2012. The breakup details is as follows:

- 4. The Government after careful consideration of the proposal of the Commissioner of Agriculture accord Administrative approval for implementing the Macro Management of Agriculture Schemes at a financial outlay of Rs.3134.920 lakhs (Rupees thirty one crore thirty four lakhs and ninety two thousand only) during the year 2011-12 and also release the first instalment of Rs.1587.078 (Rupees fifteen crores eighty seven lakhs and seven thousand eight hundred only.) (Government of India Share Rs.1388.635 lakhs unspent balance of Rs.44.16 lakhs and State Share Rs.154.283 lakhs)
- 5. The Amount sanctioned inpara 4 above shall be debited to the detailed head of accounts as indicated in the Annexure II.
 - 6. The pattern of assistance by Central and State is in the ratio of 90:10
- 7. The guidelines of Government of India in implementing the schemes are to be followed without any deviation.
- 8. The Commissioner of Agriculture and Chief Engineer (Agricultural Engineering) are directed to issue suitable executive instructions to the Officers concerned for the implementation of the schemes.
- 9. The Commissioner of Agriculture is authorized to draw the amount sanctioned for National Watershed Development Project for Rainfed Areas (NWDPRA) and to deposit it in the PD Account of Tamil Nadu Agriculture Watershed Development Agency for implementation of the scheme as per the financial sanction.
- 10. The Chief Engineer (Agricultural Engineering) is requested to send consolidated Monthly/Quarterly/Annual Progress Reports and Utilization Certificates to the Commissioner of Agriculture, Chennai-5, who in turn will consolidate and sent them

to Government for onward transmission to Government of India, Ministry of Agriculture Department of Agriculture & Co-operation, New Delhi.
